# **TERMS & CONDITIONS**

### 1. Scope of Work:

Ministry of Coal, government of India invites tenders/bids for cable/dish TV service for various offices of Ministry of Coal, New Delhi. There are about 25 connections in two different buildings of Ministry of Coal. Successful Bidder will be given the work related to providing cable/dish TV programming channels. Detailed address of two different buildings is following:

- I. Ministry of Coal,Lok Nayak Bhawan,Khan Market, New Delhi- 110 003.
- II. Shastri Bhawan, Ministry of Coal, New Delhi- 110 001.

### 2. Eligibility Criteria:

The Bidder should have a turnover of at least Rs. 10,00,000/- (Rupees Ten Lakh Only) per annum in the financial year preceding the tender. The Bidder should meet all conditions of this tender notice and should not be disqualified by any condition mentioned in the tender notice.

### 3. Technical Specifications:

Successful Bidder to provide cable service with all the International National, Regional News channels along with entertainment Channels. Bidder should have sound infrastructure facilities, financial capabilities for supply and maintain good quality of Cable/Dish TV channel service to the Ministry for period of one year.

# 4. Time frame for completion of work:

Initial installation by a successful bidder would be required to be completed without any gap in the connectivity of current cable/Dish TV service being provided. Successful Bidder would be required to install/remove a new connection in two working days. Subsequent technical problems of cable subscription must be sorted out same day with 4 hrs. of complaint being lodged at a centralised complaint Number. The Ministry may extend time frame by one in exceptional circumstances with prior request.

## 5. Tender document Availability:

# 6. Price, EMD and Performance Guarantee:-

The price quoted should be against the monthly subscription for the high-end bouquet of all channels available. Bidder also may quote the rate for new connection cost with all deliverable i.e. Set Top Box, remote, wire etc per connection. An amount of Rs. 10,000 (Rupees Ten thousand only) will have to be deposited as an Earnest Money Deposit (EMD) with the bid in the form in favour of PAO, Ministry of Coal, New Delhi. The EMD will be returned to unsuccessful Bidder without any interest, within one month after the completion of the selection process. In case Bidder withdraws or changes his quotation, Earnest Money Deposit will be forfeited. The successful Bidder will have to deposit Performance Guarantee in the form of Demand Draft or Bank Guarantee from Commercial Bank in favour of PAO, Ministry of Coal, New Delhi equivalent to 10% of the total value of the contract within 15 days of selection. The Bank Guarantee or Demand Draft should be valid for a period of one year. EMD, Demand Draft or Bank Guarantee deposited with Ministry of Coal shall earn no interest.

The Ministry reserves the right to relax any term or condition or to call tender off with the approval of the competent authority of Ministry of Coal.

#### 10. Instruction to Bidders:

A Bidder should meet prescribed eligibility criteria and observe condition of the tender document. The quotation/bids should reach on or before 1730 hrs on 15.01.2018 at Room No. 104-C Wing, 1<sup>st</sup> Floor, Ministry of Coal, Shastri Bhawan, New Delhi. Ministry of Coal may, at its discretion, extend the deadline for submission of bids by amending the bidding document, in which case all rights and obligations of Ministry of coal and the Bidder previously subject to the original deadline will thereafter be subject to the deadline as extended. Incomplete applications will be liable to be rejected.

# 11. Contract/Notification of Award/Letter of Acceptance of Award:

Ministry of Coal will notify the successful Bidder by fax/e-mail and confirm by letter on the address provided that his/her bid has been accepted by Ministry of Coal. The successful Bidder shall convey his 'Acceptance of Award" by return e-mail, fax or letter on address of the Ministry within 14 days of receipt of communication. The notification letter by Ministry of Coal to the successful Bidder and the acceptance of the Award by the Bidder in the notification letter will constitute the contract between the two parties. No advance payment will be made by the Ministry to successful Bidder.

#### 12. Termination/Penalty clause:


