It may be noted that the above exercise is being carried out as per the Hon'ble Delhi High Court which has delivered a common order dated 30.10.2014 in W.P (C) No.4653/2014 & CM 9280-81/2014 and 41 other connected matters filed against Government's action of de-allocation and/or imposition/invocation of Bank Guarantee (BG) of the allocated coal blocks, directing the Union of India to dispose of the matter of BG in eight weeks' time which was subsequently extended upto 31st March, 2015. The Operative part of the order dated 30.10.2014 has since been mentioned in Ministry of Coal's letter of even number dated 20th February, 2015. So

far no reply/comments of the State Government to the replies of the prior allocatees forwarded to State Government has been received in the Ministry of Coal.
