

CHAPTER – IV

REVIEW OF PAST PERFORMANCE

Sector – wise Coal Demand as assessed by Planning Commission

4.1 There has been continuous increase in the sector-wise as well as overall demand for coal over the years. The demand from Power sector in particular has increased significantly from 339.15 million tonnes (including middling) in the terminal year of Xth Plan (2006-07) to 396.89 million tonnes in 2008-09. It is estimated to be 441 million tonnes for the year 2009-10. The projected demand for the year 2010-11 is 486 million tonnes. Sector-wise total coal demand during 2006-07 to 2011-12 (projected) is given below:-

Through a sustained programme of investment and greater thrust on application of modern technology, it has been possible to raise the production of coal from a level of about 96 million tonnes at the time of nationalization of coal mines in the early seventies to about 492.95 million tones (All India) by 2008-09. Targeted coal production in the year 2009-10 will be to a level of 532.83 Million tonnes. With a view to meet the increased demand of coal, new coal mining projects and welfare activities are proposed to be taken up.

4.3 Lignite

Review of the Plan Schemes

Research & Development Projects

- 4.4 The Government of India through Ministry of Coal's Science & Technology (S&T) Plan and Coal India Limited through its R&D Board support R&D activities for improvement in production, productivity and safety in coal mines, coal beneficiation and utilisation and protection of environment and ecology. Adequate funds are being

earmarked annually by the Ministry of Coal and CIL R&D Board to carry out research work on the above subjects in coal and lignite sector.

- 4.5** Standing Scientific Research Committee (SSRC) under the Chairmanship of Secretary (Coal) is the Apex Body to administer coal related research activities and research grant of Coal India is administered through CIL R&D Board under the Chairmanship of Chairman, CIL.
- 4.6** Central Mine Planning and Design Institute (CMPDI) is the nodal agency for coordination and monitoring of Coal S&T and CIL R&D projects. These projects are being implemented by various research and academic institutes related to coal and allied industries with active participation of coal and lignite mining companies. Besides being the nodal agency, a number of research projects have also been implemented / are being implemented by CMPDI.
- 4.7** The status of Coal S&T Projects funded by Ministry of Coal under Coal S&T Grant during the X plan & XI Plan period (till 31.12.2009) is given below:

Promotional Exploration in Coal and Lignite

4.8 GSI, MECL and CMPDI are continuing Promotional Exploration in XI plan under the MoC's plan scheme of Promotional Exploration for Coal & Lignite. The summary of Promotional Drilling carried out in Coal & Lignite sectors in 2008-09 and programme for 2009-10 & 2010-11 are given below:

Note: 1) During the period April to December 2009, a total of 76,289m of promotional drilling has been carried out. Out of it, 23,758m has been drilled in CIL command area, 8,723m in SCCL command area and 43,807m in lignite areas. A total of 12 Geological Reports [coal (11) and lignite (1)] have been submitted during the period.

2) Under Integrated Coal Reserves Information System (ICRIS) project, map data capture of 1538 maps has been finalized and work on more maps is continuing. Integration of survey of 92 blocks has been brought to a single origin. Processing of data for creation of Geological models is progressing and 10 models have been prepared during the period April to December 2009.

3) Under Integrated Lignite Reserves Information System (ILRIS) project, scanning of 1233 Geophysical Logs of exploratory boreholes drilled in 5 lignite blocks, geological modelling of four lignite blocks through MINEX software and data uploading of seven geological/other reports has been completed during April to December '09. Compilation of seasonal reports of CGM/Gujarat for Surat & Bharuch

districts for creation of database and action for procurement of Open Series Maps from Survey of India for datum transformation are under process.

4) CMPDI and GSI have collected samples from seven boreholes for Coal Bed Methane (CBM) studies. Collection of samples from two more boreholes is going on. The analysis of collected samples and preparation of one CBM report was under progress during the period April to December 2009.

Detailed Exploration in Non-Cil Blocks

- 4.9** The exploratory drilling in Non-CIL/Captive Mining blocks is taken up under Ministry of Coal 's plan scheme of Detailed Drilling in Non-CIL Blocks.
- 4.10** The details of actual drilling in Non-CIL/Captive Mining Blocks in 2008-09 and programme for 2009-10 & 2010-11 are given below:

Note: During the period April to December 2009, a total of 1,53,778m of detailed drilling has been carried out in Non-CIL/Captive Mining blocks falling in CIL Command Area. Out of it, 60,278m has been drilled through departmental resources and 93,500m of drilling has been carried out through outsourcing. IGR of one block has been submitted during the period and GR of one more block is under preparation.

Environmental Measures And Subsidence Control

- 4.11** The objective of this scheme is to improve the environmental conditions in the old mined out areas of Jharia and Raniganj Coalfields by addressing fire and subsidence problems.
- 4.12** Major thrust areas in EMSC during the XI Plan period are the following:-
- (a) Control of subsidence in the old, abandoned waterlogged workings in Raniganj Coalfields.
 - (b) Control of mine fires and subsidence in Jharia Coalfields.
 - (c) Reclamation of mined-out areas in older coalfields like Raniganj, Jharia, Bokaro, Karanpura, etc.
 - (d) Rehabilitation of unstable and fire affected areas in Jharia and Raniganj Coalfields.
- 4.13** The problem of subsidence in the old, abandoned and waterlogged workings has arisen due to unscientific mining carried out under shallow cover in the past and is mainly confined to Raniganj coalfield of West Bengal. For this problem of Raniganj Coalfield, an Apex Monitoring Committee consisting of representatives of Coal Company, District Administration, Directorate General of Mines Safety, Central Mining Research Institute and peoples' representatives (M.P., MLA etc.) was constituted by CIL in 1990.
- 4.14** Occurrence of fires in coal mines is due to the phenomenon of spontaneous combustion which is inherent in Indian coals. The first occurrence of coalfield fire in Jharia was reported in 1916. At the time of nationalisation of coking coal mines in 1971, there were 70 active fire sites spread over an area of about 17 Sq.km. Out of these, 10 fires have been extinguished so far. Further work is in progress.

Master Plan For Jharia & Raniganj Coalfields

- 4.15** For dealing with the problem of subsidence and fire in Raniganj and Jharia Coalfields, in a comprehensive manner, a Committee was constituted by Govt. of India in December 1996 with Secretary (Coal) as Chairman and representatives of Planning Commission, Ministry of Labour, Govt. of West Bengal, Govt. of Bihar, Directorate General of Mines Safety, CIL, CMPDI, BCCL and ECL as members. The Committee submitted its report in December 1997. The recommendations of the Committee were accepted by the Government. Accordingly, Master Plans for rehabilitation of unstable and fire affected areas was drawn up for Jharia and Raniganj Coalfields and was subsequently updated in March /April, 2008.
- 4.16** The Government has approved the Master Plan dealing with fire, subsidence and rehabilitation and diversion of surface infrastructure within the leasehold of Bharat Coking Coal Limited (BCCL) & Eastern Coalfields Limited (ECL) on 12th August, 2009 at an estimated investment of Rs.9773.84 crores (Rs.7112.11 crores for Jharia Coal Field (JCF) and Rs.2661.73 crores for Raniganj Coal Field (RCF) including Rs.116.23 crores sanctioned earlier for various Environmental Measures & Subsidence Control (EMSC) schemes. The Master Plan is scheduled to be implemented in ten years time and in case of BCCL two additional years for pre-implementation activities. All the EMSC Schemes have been subsumed. The scheme is funded through EMSC Plan Scheme of Ministry of Coal..
- 4.17** Asansol Durgapur Development Authority (ADDA) and Jharkhand Rehabilitation Development Authority (JRDA) have been notified by the state Governments of West Bengal and Jharkhand respectively as implementing agencies for rehabilitation purposes. Coal companies (ECL & BCCL) will provide technical support and the outlay will be funded partially through the internal resources of CIL and the cess collection under CCDA.

The implementation of the Master Plan for Jharia and Raniganj Coalfields is being monitored by the High Powered Central Committee constituted by this Ministry under the chairmanship of Secretary (Coal). The first meeting of this committee was held on 10.11.2009.

Conservation & Safety in Coalmines and Development of Transport Infrastructure under CCDA.

- 4.18** These schemes were partially subsidized through Non-Plan provisions for the last 31 years in the form of reimbursement to the Coal Mine owners as per the statutory provisions under the Coal Mines (Conservation and Development) Act.1974 primarily to ensure conservation of coal with related safety aspects of the coal mines and also to facilitate smooth movement of the coal to the consumers at large through infrastructure development. The said Act empowers Central Government to collect duty of excise on all coal produced and despatched from all the collieries in India (actually paid by the consumers) and to disburse ,in each financial year, a sum not exceeding a net proceeds from such collection during preceding year or years, to owners, agents or the managers for execution of stowing and other operations for the safety in coal mines or conservation of coal, prosecution of research work connected with the conservation of coal or development of coal mines and any other purpose connected with the conservation of coal or transportation, distribution or utilising of coal. The principal objective of the Act is to collect excise duty on coal for disbursing the same in total back to the coal mines for conservation and development related works including infrastructure development.
- 4.19** The examination and scrutiny for reimbursement are done by a duly constituted ‘Coal Conservation and Development Advisory Committee’ (CCDA Committee) as per the provisions of Coal Mines (Conservation & Development) Rules, 1975. The Government partially reimburses (rest being borne by Coal Companies) these amount to the coal companies through budget provision taking into account the liability already existing during the preceding financial year. The requirement is assessed by the CCDA Sub-committee, followed by the CCDA Committee.

Development of North Eastern Region/Sikkim

4.20 As per relevant instructions on the subject, 10% of the Plan Outlay is required to be earmarked for Development of North Eastern Region/Sikkim. If the amount is not spent, the same is transferred to the Non lapsable pool of the Central Government.

Projects Implemented by PSUs from their Internal and Extra Budgetary Resources (IEBR)

4.21 The projects are implemented by Coal PSUs using their own Internal and Extra Budgetary Resources (IEBR) and the Government does not provide any Budgetary support to them. The statement showing company wise and project wise status and details of projects costing Rs.100 crores and above are given in the **Annexure**.
