In continuation of this Ministry's de-allocation letter of even number 17th February, 2014 and to the Show Cause Notice issued to your company vide this Ministry's letter No.13016/17/2014-CA-I dated 16th January, 2015 on the above subject, I am directed to say that the issue of Bank Guarantee in r/o **Fatehpur** coal block has been deliberated in the 31st meeting of Inter-Ministerial Group (IMG) held on 7th July, 2015 wherein at para 7 of the said minutes, the IMG reviewed the Bank Guarantee (BG) of Fatehpur coal block based on the calculation for deduction/forfeiture of BG done by Coal Controller's Organisation(CCO). The calculation sheet for BG as prepared by CCO was placed before the IMG in its 31st meeting. IMG considered the same and recommended that BG ought to be deducted for delay on the part of prior allottees. As per this calculation BG to be deducted for not achieved milestones is **Rs.0.3834 crore.** The recommendations of 31st IMG meeting has been accepted by the Government.

2. Accordingly, an amount of **Rs.0.3834 crore** (Rupees thirty eight-lakhs thirty four thousand only) from the Bank Guarantee furnished by you is determined to be deducted and deposited with the Government.
