Transfer of compensation towards cost for Land and Mine Infrastructure in respect of Lohari coal mine to the Commissioner of Payment for further disbursal to the prior allottee i.e. M/s. Usha Martin Ltd.

#### Sir/Madam,

I am to convey the sanction of the President to the transfer of a sum of Rs. 2,17,71,839.00/- (Rupees Two crore Seventeen lakh Seventy one thousand Eight hundred thirty nine only) to the Coal Controller's Organisation for disbursement to M/s. Usha Martin Ltd., the prior allottee, of Lohari coal mine under the provisions of the Coal Mines (Special Provisions) Act, 2015 by the Coal Controller in his capacity as Commissioner of Payments' towards compensation for Land and Mine Infrastructure.

2. Here, it is pertinent to mention that in accordance with the Coal Mines (Special Provisions) Act, 2015 ("Act") and the Coal Mines (Special Provisions) Rules, 2014 ("Rules"), the Nominated

Authority had issued notices dated March 12, 2015, April 22, 2015, September 17, 2015, December 15, 2015 and June 02/03, 2016 inviting claims from Secured Creditors/Government Authorities in respect of Schedule I coal mines.

- 3. In pursuance to the aforesaid notices, no claims were received in respect of Lohari coal mine. However, the successful bidder of the coal mine, M/s. Araanya Mines Private Limited, vide letter No. AMPL/12/2016-17 dated 06.06.2016 had requested to hold the payment of compensation amount to the prior allottee claiming that information of land acquired was incorrectly given by the prior allottee. bidder videsuccessful further letter No. AMPL/20/2016-17 dated 15.09.2016 requested to hold the payment of compensation amount to the prior allottee giving details of difficulties being faced by them.
- In order to examine the matter, the successful 4. bidder as well as prior allotted of the said coal mine were called by Nominated Authority for a hearing on 18.10.2016 at the office of the Nominated Authority. The representatives of M/s. Araanya Mines Private Limited (AMPL) and that of M/\$. Usha Martin Limited (UML) were present at the hearing. The submissions made by M/s. AMPL and M/s. UML were considered and examined and Speaking Order bearing no. 110/9/2015/NA (Part) dated 31.10.2016 enclosed) has been passed in the matter. As per the said speaking order the details of the amount to be released to the Commissioner of Payment for onward disbursal to the prior allottee is as under:-

- 5. mentioned that an amount of Rs. 32.02 1,35,76,835/towards compensation Hectare of land for mining (as per Mining Lease) has been withheld in terms of the aforesaid Speaking Order. It is also pertinent to mention that reestimation of compensation for land (earlier done till 24.09.2014) in respect of Lohari coal mine till the date of vesting order (till 22.04.2015) has been carried out later and the successful bidder is yet to pay Rs. 20,41,209/- towards the incremental amount. The same will be released subsequently.
- 6. The amount of **Rs.** 2,17,71,839.00/- may be transferred through RTGS to the account of Coal Controller, Coal Controller's Organisation who has been appointed as 'Commissioner of Payments' under the provisions of Section 15 (1) of the Coal Mines (Special Provisions) Act, 2015 for the purpose of the said Act vide Ministry of Coal's Order No. 22/2/2014-ASO dated 15<sup>th</sup> July, 2015.
- 7. The expenditure on this account is debitable to the Head **8443.00.117.03.04.00**.
