OFFICE MEMORANDUM


Subject:- Meeting for establishment of Claims submitted by the Banks/Financial Institutions under the provisions of the Coal Mines (Special Provisions) Act, 2015.

Attention is invited to Section 16 of the Coal Mines (Special Provisions) Act, 2015 which provides for valuation of compensation for land and mine infrastructure in relation to Schedule I Coal Mines, for payment to prior allottees. Further, Rule 15(2) of the Rules stipulates that the Nominated Authority may invite persons other than the prior allottee to submit their claims with proof of their respective claims.

2. Accordingly, the Nominated Authority issued notices dated 12th March 2015, 22nd April, 2015, 17th Sept 2015 & 15th Dec 2015 inviting claims in respect of Schedule I coal mines. In pursuance to aforesaid notices, claims have been submitted by various organisations in respect of Schedule- I coal mines. However, it has been noticed that in most of the cases claims have been submitted without appropriate/requisite documents/information leading to difficulty in establishing the claims.

3. In this regard, it has been decided to hold a meeting in order to establish the claims submitted by Banks/Financial institutions in respect of coal mines for which Vesting/Allotment orders have been issued till date. The meeting is scheduled to be held on **22nd June, 2016 at 10.00 A.M. in the Conference Room, 6th Floor, SBI Capital Markets Limited, World Trade Tower, Barakhamba Lane, New Delhi-110001.**

4. It is, therefore, requested that representative(s) (maximum 02) of your Organization/Banks as per Annexure-1, may please be nominated for attending the meeting.
