**SUBJECT: NOTICE FOR SUBMISSION OF CLAIMS IN RELATION TO
ALLOTMENT OF SCHEDULE II & III COAL MINES**

In accordance with the provisions of Section 9 of The Coal Mines (Special Provisions) Second Ordinance, 2014 and Rule 15 of The Coal Mines (Special Provisions) Rules, 2014, the following are requested to submit their claims, if any, along with proof of their respective claims in relation to the Schedule II & III Coal Mines as given in Annexure I:

i) Secured Creditors: for any portion of the secured debt which is unpaid as on the date of the Vesting Order;

ii) Government of India, any of the departments or ministries of the Government of India: for all revenues, taxes, cess, additional levy and rates due from the prior allottee on **31.03.2015** and having become due and payable immediately before that date;

iii) State Government(s), any of the departments or ministries of the State Government(s): for all revenues, taxes, cess, additional levy and rates due from the prior allottee on **31.03.2015** and having become due and payable immediately before that date; and

iv) Local Authority (ies): for all revenues, taxes, cess, additional levy and rates due from the prior allottee on **31.03.2015** and having become due and payable immediately before that date.

The abovementioned claims along with proof of the respective claims are required to be submitted in a sealed envelope, super scribed on the top as "Submission of Claims for [insert name of the Coal Mine]" before 12:00 noon on April 28th, 2015 at the **O/o the Nominated Authority, World Trade Tower, Ground Floor, Barakhamba Lane, New Delhi - 110001.**

3. Scanned copies of the aforementioned claims are required to be sent on the email id: nomauthority.moc@nic.in before 12:00 noon on April 28th, 2015. The email should clearly bear the following subject line: "Submission of Claims for [insert name of the Coal Mine]".

4. It may please be noted that any claim received after 12:00 noon on April 28th, 2015 shall not be considered.
