**Notice to the Bidders of Schedule III Coal Mines put up for Auction in
Fourth Tranche for Site Visit and Inspection of Land Documents**

A schedule (as annexed) has been drawn up for Site Visit/ inspection of land documents by the bidders who have purchased tender document after making payment of prescribed fee.

2. The bidders are requested to intimate their willingness along with the preferred date mine-wise as per the schedule in the Annexure and intimate the same on the email ID: na.moc@nic.in by 05 PM on 10th December, 2015.
3. The email should clearly bear the following subject line: "Requesting Site Visit for [insert name of the coal mine]" and "Request to inspect land documents for [insert name of the coal mine]". Separate emails for site visit and land documents per coal mine should be sent.

While intimating preferred date, *Bidders are requested to provide two (or) three alternative dates for Site visit/ inspection of land documents from the slot given for the coal mine.* Name of the representatives of your company and his/her contact details (email & mob. no) may also be intimated. While visiting the site/inspection of land documents, the representative concerned must carry an authorisation letter from the bidder company and a photo ID.
5. Bidders who have purchased tender document for Schedule III coal mines put for auction and intimated their willingness by e-mail on na.moc@nic.in are requested to contact Shri OP Dubey on his mobile no. +91-9953633773 to schedule date and time for site visits.

For inspection of land documents at the office of Nominated Authority Ground Floor, World Trade Tower, Barakhamba Lane, New Delhi-110001, an e-mail intimating the date and time for inspection would be sent to the same e-mail id through which the request for inspection of land documents is sent by the bidders.

It may please be noted that any request for changes in the date and time fixed for site visit/ inspection of land documents will not be entertained.
