Particulars	Existing Norms for projects being developed on departmental/partial/ total outsourcing mode [Ref: order dated 24.3.2021]	Norms for projects being developed in MDO Mode
Coal Production	Achievement of 80 % coal production of the normative capacity of the Project.	Achievement of 80% coal production of the normative capacity of the Project.
Mine Development	Completion of all major facilities and initial mine Development works.	Completion of all major facilities and initial mine development works by the MDO as per approved Mining Plan /Project Report.
Capital Investment	80% of the capital investment	80% of the entire capital expenditure both by CIL and MDO


