Sir/Madam,

I am to convey the sanction of the President to the E- Payment of a sum of **INR 1,82,195/-** ( In words:-One Lakh Eighty Two Thousand One Hundred Ninety Five Only) to the Successful Allottee, M/s JSW Steel Limited ' under the provisions of the Coal Mines (Special Provisions) Act, 2015 by the Coal Controller in his capacity as 'Commissioner of Payments' towards Land. It is stated that the above mentioned amount is a part of Fixed Amount deposited by the Successful Bidder of coal mine.

2. Here, it is pertinent to mention that earlier order dated December 27, 2016 compensation of Rs. 23,31,23,753/- out of total Rs. 25,95,90,113/- for Land and NIL for Mine Infrastructure has been released to M/s UCO Bank (Lead Bank), secured creditor of prior allottee against proceeds arising out of Land and Mine Infrastructure/ compensation in respect of Moitra coal block under section 9 of CM (SP) Act, 2015.

3. As per Final order dated September 02,2022 , M/s JNIL is entitled to get compensation amounting to Rs.2,62,84,165/- and successful allottee is entitled to get back Rs.1,82,195/- against the withheld amount of Rs.2,64,66,360/- pertaining to Moitra coal block.

4. Therefore, The aforesaid amount may be transferred through E-Payment to Successful Allottee, M/s JSW Steel Limited' under the provisions of Section 15(1) of the Coal Mines (Special Provision) Act, 2015.

5. The expenditure on this account is debited to the Head **8443.00.117.03.04.00**.
