FINAL ORDER

Subject: Determination of Compensation for Cost of Geological Report ("GR"), Cost of Consents ("CC"), Cost of Land and Cost of Mine Infrastructure payable to the prior allocattee of Sahapur West Coal Mine, viz. M/s National Mineral Development Corp. in terms of the Coal Mines (Special Provisions) Act, 2015 and Judgment dated March 09, 2017 passed by Hon'ble High Court of Delhi – Reg.

In pursuance to Order dated September 01, 2022, determining the disbursal of compensation amount for Cost of Geological Report ("GR"), Cost of Consents ("CC"), Cost of Land and Cost of Mine Infrastructure in relation to Sahapur West Coal mine , the prior allottee M/s. National Minerals development Corporation (NMDC.) as well as the present allottee M/s. Sarda Energy and Minerals Limited (M/s. SEML) were called upon on September 12, 2022 at 12.30 P.M to present their comments/objection, if any, on the determination made by the Nominated Authority.

- 2. Subsequently, both the prior allottee and present allocattee attended the meeting on September 12, 2022 at 12.30 P.M. In the meeting, it was informed by the prior allottee (M/s. NMDC) that in the valuation of compensation an amount of ₹ 1,94,76,840/- for Geological data/exploration carried out by CMPDIL for Sahapur East & West coal mine has not been included. Furthermore, prior allottee also requested O/o NA to include additional amount pertaining to Tax Deducted at Source in the compensation.
- 3. Thereafter, objections raised by the prior allottee (M/s. NMDC) were re-examined by O/o NA. In the matter of inclusion of ₹ 1,94,76,840/- for the geological data/exploration carried out by CMPDIL, O/o NA vide email dated September 12, 2022 sought clarifications & details from CMPDIL regarding the cost of exploration in relation to the said coal mine. The details sought were furnished by the CMPDIL vide email dated September 20, 2022 (copy enclosed) wherein an amount of ₹70,04,530/- was admitted by CMPDIL for the exploration of the said coal mine. For the matter related to TDS amount, O/o NA vide email dated September 22, 2022 sought supporting documents from M/s. NMDC to substantiate their claim. M/s NMDC on October 10, 2022 submitted relevant supporting documents & based on which an additional amount of ₹ 9,06,743/- was admitted this office.
- 4. Consequently, Provisional Order dated October 20, 2022(copy enclosed) was issued re-determining the compensation payable to the prior allottee. Details of which may be found below in the table marked as 'A':

In pursuance to the said order (dtd 20-10-2022) following the principle of natural justice, another opportunity of hearing was provided to both the prior allottee (M/s NMDC.) and present allottee (M/s. SEML) of Sahapur West Coal mine and a meeting was convened on October 27, 2022 at 11:00AM to present their comments/objection, if any, on the redetermination made by the Nominated Authority. In the meeting no objections/queries were raised by both the prior allottee (M/s. NMDC) and present allottee (M/sEML) against the redetermined amount for Cost of Geological Report, Cost of Consent, Cost of Land and Cost of Mine Infrastructure.

5. In view of above, the valuation of Compensation for Geological report, Cost of Consent, Land and Mine infrastructure stands final as ₹ 4,93,71,473 (Rupees Four Crore Ninety Three Lakh Seventy One Thousand Four Hundred and Seventy Three only) enumerated in Table B below:

SEML) minus ₹ 4,93,71,473 (Revised compensation Amount)] will be returned to the successful allocattee (M/s. SEML) on account of excess Fixed Amount deposited by them for Cost of Geological Report pertaining to Sahapur West coal mine.

7. In accordance with Section 27 of the Act and the judgment dated 09.03.2017, it is open to M/s. NMDC and M/s. SEML to raise disputes with regard to the quantum of compensation before the Tribunal constituted under the Coal Bearing Areas (Acquisition and Development) Act, 1957.

PROVISIONAL ORDER

Subject: Determination of compensation for Cost of Geological Report ("GR") and Cost of Consents ("CC") payable to the prior allocattee of Sahapur West Coal Mine, viz. M/s National Mineral Development Corporation in terms of the Coal Mines (Special Provisions) Act, 2015 and Judgment dated March 09, 2017 passed by Hon'ble High Court of Delhi – Reg.

Prior to cancellation of 204 coal blocks by Hon'ble Supreme Court of India in 2014, Sahapur West Coal Block was allocated to M/s National Mineral Development Corp (NMDC). Post cancellation the said block has been allocated to M/s Sarda Energy And Minerals Limited (SEML) under the Coal Mines (Special Provisions) Act, 2015 (CMSP Act, 2015) and Vesting Order has been executed on 03rd March, 2021 (enclosed). Prior Allocatee is entitled to receive compensation in the manner as laid down in the CMSP Act, 2015.

- 2. Provisional order for the compensation of GR & CC was issued on September 01, 2022, wherein payable compensation payable to the prior allottee was determined as ₹ 4,14.60,200.00/- and ₹ NIL/- for GR & CC respectively. In reference to the said order, prior allottee (M/s NMDC.) and present allottee (M/s. SEML) of Sahapur West Coal mine were called upon on September 12, 2022 at 12.30 P.M to present their comments/objection. In the meeting, it was informed by the prior allottee (NMDC) that in the valuation of compensation, total amount of ₹ 1.94,76.840/- for the exploration of Sahapur East & West coal mine carried out by CMPDIL has not been included. Furthermore, prior allottee also requested O/o NA to include additional amount pertaining to Tax Deducted at Source in the compensation.
- 3. Thereafter, O/o NA re-examined the matter of compensation and vide email September 12, 2022 sought clarifications & details from CMPDIL regarding the cost of exploration in relation to the said coal mine. The details sought were furnished by the CMPDIL vide email dated September 20, 2022 (copy enclosed) wherein for an amount of ₹ 70,04,530/- out of ₹ 1,94,76.840/- was admitted by CMPDIL for the exploration of the Sahapur West coal mine. For the matter related to TDS amount, O/o NA sought supporting documents from M/s. NMDC vide email dated September 22, 2022 to substantiate their claim. M/s NMDC on October 10, 2022 submitted relevant supporting documents & based on which an additional amount of ₹ 9,06,743/- has been admitted.
- 4 Accordingly, O/o NA has re-determined payable compensation to the M/s. NMDC (prior allottee) details of which may be found below in the Table 'A'.
