NOTICE

SUBJECT: NOTICE FOR SUBMISSION OF CLAIMS IN RELATION TO COMPENSATION OF SCHEDULE I COAL MINES.

1. In accordance with the provisions of Section 9 of The Coal Mines (Special Provisions) Act, 2015 and Rule 15 of The Coal Mines (Special Provisions) Rules, 2014, the following are requested to submit their afresh claims, if any, along with proof of their respective claims in relation to compensation of the Schedule I coal mines as given in **Annexure I:-**

- i. Secured Creditors: for any portion of the secured debt which is unpaid as on the date of the Vesting Order;
- ii. Government of India, any of the department or ministries of the Government of India: for all revenues, taxes, cess, additional levy and rates due from the prior allottee on **31.03.2015 & 24.09.2014** and having become due and payable immediately before that date;
- iii. State Government(s), any of the department or ministries of the State Government(s): for all revenues, taxes, cess, additional levy and rates due from the prior allottee on **31.03.2015 & 24.09.2014** and having become due and payable immediately before that date; and
- iv. Local Authority (ies): for all revenues, taxes, cess, additional levy and rates due from the prior allottee on **31.03.2015 & 24.09.2014** and having become due and payable immediately before that date.

2. The above mentioned claims along with proof of the respective claims are required to be submitted in a sealed envelope, superscribed on the top as "Submission of Claims for [insert name of the coal mine]" before 12:00 noon on December 20, 2022 at the O/o **Nominated Authority, Room No. 120-F, 1st Floor, Shastri Bhawan, New Delhi-110001.**

3. Scanned copies of the aforementioned claims are required to be sent on the email id: nomauthority.moc@nic.in upto **5:00 P.M of December 20, 2022** The email should clearly bear the following subject line: "Submission of Claims for [insert name of the Coal Mine] "

4. It may please be noted that any claim received after **5:00 P.M 20.12.2022** shall not be considered.

5. It is clarified that in case a mining lease has been executed in favour of a third party, subsequent to such allocation of Schedule I coal mines, then, the third party shall be deemed to be the prior allottee as per Section 3 (1) (n) of the Coal Mines (Special Provisions) Act 2015.


6. Claims lodged against earlier advertisements in respect of Schedule I coal mines are also required to be lodged afresh.

7. Claimants are required to specify the following category (ies) against their claims:-

- a. Government of India, any of the department or ministries of the Government of India: for all revenues, taxes, cess, additional levy and rates.
- b. State Government(s), any of the departments or ministries of the State Government(s): for all revenues, taxes, cess, additional levy and rates.
- c. Local Authority (ies): for all revenues, taxes, cess, additional levy and rates due.
- d. Any another.

8. All the claims must be accompanied with an affidavit in the enclosed format (**Annexure II**), duly sworn in by the claimant.
