

## Monthly Summary for the Cabinet for the month of February, 2023 in respect of Ministry of Coal

### Principal Activities

The core objectives of the Ministry of Coal are to augment coal production by adopting state-of-the-art clean-coal technologies; enhancing exploration efforts with thrust on increasing proven coal resources and developing necessary infrastructure for prompt evacuation of coal for securing its availability to meet the demand of different sectors of the economy in an eco-friendly and sustainable manner.

### Important achievements

#### **Steps taken for sustained production of coal:**

- i. Meeting under the Chairmanship of Secretary (Coal) to review the coal production status from Captive and Commercial Coal mines allocated by Ministry of Coal on 02.02.2023.
- ii. 1<sup>st</sup> Meeting of Technical Evaluation Committee was held on 09.02.2023 for evaluation of bids in 2<sup>nd</sup> attempt of 15<sup>th</sup> tranche and 16<sup>th</sup> Tranche of Auction of coal mines under CMSP Act, 2015 and 6<sup>th</sup> tranche of Auction of coal mines under MMDR Act, 1957-reg.
- iii. Meeting was held on 14.02.2023 to review the coal production from Captive/Commercial Coal Mines.
- iv. Production in the month of February 2023 from mines allocated under CM (SP) Act, 2015 is 10.90 Million Tonne.
- v. Revenue in the month of February 2023 from mines allocated under CM (SP) Act, 2015 is Rs. 247.37 Crore.
- vi. Directions have been issued to Nominated Authority vide OM dated 03.02 .2023 to conduct the auction for the purpose of sale of coal in respect of 5 coal mines, namely, Tara, Vijay Central, Tandsi-III &Tandsi-III (Extn.), Mahan and Mara-II Mahan.
- vii. The coal controller organization has reported that the total production of Coal from the allocated captive coal blocks for the month of **February, 2023** is **11.192 Million Tonnes (Provisional)** , out of which, aggregate coal production of those coal blocks which have not been cancelled by the Hon'ble Supreme Court viz. Pakri Barwadih ( **1.433 MT** ), Tasra ( **0.031 MT**) and Moher & Moher Amlori Extn. ( **0.976 MT** ) is **2.440 Million Tonnes (Provisional)**
- viii. During the month of February, 2023, directions have been issued to Nominated Authority for allocation of 21 coal blocks by way of auction for sale of coal.

- The outstanding dues payable by Power Sector to CIL and SCCL as on 28.02.2023 were 16629.41 crore and Rs. 3713.15 crore respectively. (Provisional).

**Promotional Drilling:** A proposed programme of Promotional/NMET (Regional) drilling comprising 0.65 lakh meters in coal has been drawn up in Annual Plan 2022-23 of CMPDI. The programme is under execution by MECL, DGMs of Nagaland & Assam and CMPDI.

As against this, the achievement of drilling upto the month of February 2023 is 0.643 lakh metre, against the target of 0.591 lakh metre, which is 109% of the target.

**Overall Progress of Detailed Drilling in 2022-23:** For 2022-23, an MoU target of 7.0 lakh metre of drilling (Departmental: 4.20 lakh metre, Outsourcing: 2.80 lakh metre) has been kept. As against this, 5.635 lakh metre of drilling has been carried out upto the month of February 2023 against the target of 6.223 lakh metre, which is 91% of the target.
