Monthly Summary for the Cabinet for the month of July, 2024 in respect of Ministry of Coal

1. Principal Activities

The core objectives of the Ministry of Coal are to augment coal production by adopting state-of-the-art clean-coal technologies; enhancing exploration efforts with thrust on increasing proven coal resources and developing necessary infrastructure for prompt evacuation of coal for securing its availability to meet the demand of different sectors of the economy in an eco-friendly and sustainable manner.

2. Coal production, dispatch and supply for the month of July, 2024 are as under:

- i. Overall domestic coal production in the month of July, 2024 was **74 MT** as against **69.58 MT** in the month of July, 2023, registering a growth of about **6.35%**. It includes coal production of **55.04 MT** by CIL, **4.23 MT** by SCCL and **14.73 MT** by Captive & Other mines (Provisional).
- Overall domestic coal dispatch in the month of July, 2024 was 79.63 MT as against 76.34 MT in the month of July, 2023, registering a growth of about 4.30%. It includes dispatch of 59.57 MT by CIL, 4.23 MT by SCCL and 15.83 MT by Captive & other mines (Provisional).
- iii. Overall domestic coal supply to Power Sector in the month of July, 2024 by CIL and SCCL was **52.76** MT as against **52.24** MT in July, 2023 (Provisional).

3. Steps taken for sustained production of coal:

- i. Total coal production from captive/commercial mines in the month of July, 2024 is 14.13 MT.
- ii. Out of which, production of coal from the allocated captive coal blocks for the month of July, 2024 is 12.64 Million Tonnes (Provisional). Aggregate coal production of those coal blocks which have not been cancelled by the Hon'ble Supreme Court viz. Pakri Barwadih (1.571 MT), Tasra (NIL) and Moher & Moher Amlori Extn. (1.495 MT) is 3.066 Million Tonnes (Provisional).
- iii. Revenue worth Rs. 421.35 crores has gone to State Government (s) during the month of July, 2024.
- iv. Four (04) Coal Block Development and Production Agreement have been signed with successful bidders in July, 2024.
- v. Directions have been issued to Nominated Authority for declaration of successful bidder and issuance of Vesting Order in respect of Machhakata (Revised) coal mine auctioned for sale of coal under the provisions of CMSP Act, 2015.
- vi. Cabinet Note on "Amendments in land use policy of Central Public Sector Undertakings in Coal Sector" has been approved by the Cabinet on 18.07.2024 and guidelines have been issued by Ministry of Coal vide Order No.PS2-13011/3/2022-PS2 dated 29th July, 2024.

5. Drilling in Coal and Lignite:

Promotional Drilling in FY 2024-25: As per the approved BE for Promotional drilling, 4.50 lakh meters of drilling in coal/lignite has been envisaged in the Annual Plan of CMPDI.As against this, the achievement of drilling upto the month of July, 2024 is 0.569 lakh metre, against the target of 0.737 lakh metre, which is 77% of the target.

Overall Progress of Detailed Drilling in FY 2024-25: Annual plan target of 10.0 lakh metre of drilling (Departmental: 4.10 lakh metre, Outsourcing: 5.90 lakh metre) has been kept. As against this, 2.573 lakh metre of drilling has been carried out upto the month of July 2024 against the target of 2.497 lakh metre, which is 103% of the target.
