Minutes of the 24th meeting of Scrutiny Committee held on 08.08.2024 and 09.08.2024 to consider/examine the submissions/replies of Allottees against the Show Cause Notices for deviation from milestones mentioned in Coal Mines Development and Production Agreement.

The Chairman of the Scrutiny Committee welcomed all the members of the committee and the participants. Mine-wise discussions on Show Cause Notices and corresponding replies were held and Allotteeswere given the opportunity to share their point of views on the show cause notices.

The list of participants is given at Annexure -I.

1. MarkiBarka- M/s Birla Corporation Limited (BCL)

O/o NA also informed that the clearances such as Mining Plan, EC, FC-I etc of the Prior Allottee were vested to M/s BCL along with the vesting order. The Successful Allottee is required to get the geological block boundary certified by the CMPDIL on the basis of DGPS survey report. Subsequently, the Allottee is required to obtain all clearances for the entire geological block area. It has been made clear verbally several times to Allottee to obtain Mining Plan and other clearances for entire Geological block irrespective of the clearances vested to them. The Vested clearances such as Mining Plan, EC, FC-I were not for the same area as that of Geological block. The area corresponding to vested clearances of MP, EC and FC-I is different from the area of the geological block. Therefore, M/s BCL is required to get a Mining Plan revised for the area incorporating the whole Geological block to operationalize the entire coal block allocated. As per the efficiency parameter of CMDPA, the due date for approval of Mine Plan is 16.07.2023.

The Committee observed that, M/s BCL is required to revise the Mining Plan to encompass the entire Geological block, in order to operationalize the allocated coal block in accordance with the efficiency parameters of CMDPA. However, the Allottee has failed to obtain approval for the Mining Plan covering the entire Geological block within the stipulated timeline in the CMDPA, thereby hindering the operationalization of the entire allocated coal block.

The committee also noted that the M/s BCL's representative who are aware of the issues have failed to attend the meeting and therefore the committee was unable to get the views of the allottee. In view of the above, the Committee agreed with the request of allottee to defer the decisiontill the next meeting and advised allottee to put up their point of view in the next meeting. Accordingly, the final decision the show cause notices will be taken.

2. Amelia Coal Mine-M/s THDCIL

Due to covid-19 pandemic,Ministry of Power has given 8.5 months relaxation in commencement of the units.However, due to delays like outbreak of Covid-19, and disruptions due to the Russia-Ukraine war, the commissioning of EUPs (Unit 1 & 2)was delayed and they submitted that the same will be completed by September 2024 (Unit I) & March 2025 (Unit II) respectively.

Observations and Recommendations:

Amelia coal mine was allotted to M/s THDCIL vide vesting order dated 17.01.2017. The Committee observed that the actual date of Mine opening permission is 15.02.2022 against the scheduled date 12.08.2022. Committee noted that mine opening permission was granted before the scheduled date. They were given 3 Show Cause notices.

The Committee observed that the Allottee was already having sufficient land for achievement of PRC before the stipulated timeline. The Committee also observed that the milestone of opening of Escrow amount and application of mine opening permission were also obtained before the scheduled timeline.

Accordingly, the committee recommended for not imposing any penalty for the corresponding Show Cause Notice and it is waived off.

Regarding the issue of shortage in coal production in FY 2023-24, the committee agreed with the arguments given by the Allottee and therefore recommended for not imposing any penalty for the corresponding Show Cause Notice and it is waived off.

Regarding the issue of delay in synchronization of EUP, the Committee observed that Unit 1 of EUP was scheduled to be commissioned in 4 years from the date of commencement i.e., 08.03.2019. In addition, a relaxation of 8 ½ months was also given on account of Covid 19 from the Ministry of Power. Hence, the synchronisation for Unit 1 was scheduled by 23.11.2023. However, it is still pending. The Allottee has confirmed that the synchronization will happen in September 2024. Therefore, the Allottee themselves has admitted a delay of about 10 months in synchronization of EUP. The Committee therefore recommended for imposition of penalty in form of appropriation of PBG as per the provision of CMDPA for the milestone of EUP synchronization.

3. Marwatola VI coal mine: - M/s JSW Cement Limited (JSWCL)

Observations and Recommendations:

Marwatola VI coal mine has been allotted to M/s JSW Cement limited on 08.06.2023 and the scheduled date of operationalization of the mine is 08.09.2027. The Committee observed that the milestone MS-2, i.e., approval of Mining Plan was completed on 23.07.2024 while the scheduled date was 08.12.2023 as per CMDPA. There is delay of about 7 months. The major reason for the delay seems to be discrepancy in the geological reserve value. The Committee also noted that the Allottee has assured that the next milestone will be completed within the scheduled timeline and whatever delay has occurred in completion of MS-2 will be covered-up in completion of MS-3, i.e. grant of EC and thus delay in MS-2 will not impact completion of MS-3.

Based on the deliberation and the commitment given by the Allottee, the committee felt that an opportunity may be given to the Allottee till the scheduled date of completion of next milestone. Therefore, the committee made the following recommendation: -

- 1. The decision on this Show Cause Notice is deferred till 08.06.2025, i.e. due date for completion of MS-3.
- 2. The Allottee will give a written undertaking to O/o NA within 3 working days that the MS-3 milestone will be completed by the scheduled date, i.e 08.06.2025.
- 3. In the event the MS-3 milestone is completed by the scheduled date, i.e. 08.06.2025, the issue of MS-2 will again be put up before the Scrutiny Committee for the final decision.
- 4. However, if the MS-3 milestone is not completed by the scheduled date, the Committee recommended for imposition of penalty in the form of appropriation of PBG as per the provision of CMDPA for MS-2 milestone.

4. Brahampuri Coal Mine -M/s Birla Corporation Limited

Show Cause Notices dated 20.05.2022, 01.09.2022 & 05.06.2024 were issued for delay in achievement of FC Stage-1, FC stage-2, EC and grant of Mining Lease

		In this regard, the opinion of the Dy Solicitor General (DSG) was sought that whether show cause notice for other milestone can be given or not to the Allottee.
		In the matter, DSG vide letter dated 18.05.2024 has provided the following legal opinion: 'The Hon'ble High Court vide interim order dated 01.02.2023 passed in Writ Petition W.P. No. 1611 of 2023 directed not to take any coercive action against the petitioners therein, hence as such there is no bar to present show cause notice however pursuant to show cause notice till the subsistence of interim order no final order can be passed. The fate of final action/final order pursuant to show cause notice shall remain depend upon the final outcome

Observations and Recommendations.

The committee observed that an interim order from the Hon'ble High Court regarding a Writ Petition on the Brahampuri Coal Mine directs that no coercive action be taken against the petitioners till the next date. The final order of the Hon'ble High Court is still pending. In view of this, the Committee decided for not considering any pending show cause notices for this mine till the matter remains sub judice. Therefore, the Committee did not deliberate on the above mentioned Show Cause Notices and the corresponding replies of the Allottee. The Committee recommended to put up these issues before it only after the order of the Hon'ble court.

5. GondbaheraUjheni (East) coal mine: - M/s MP Natural Resources Private Limited (MPNRPL)

Show Cause Notice dated 18.03.2024 for delay in completion of drilling &preparation of GR, i.e MS-1and the corresponding reply dated 29.03.2024 of the Allottee were considered in the meeting.

Further, Allottee stated that the drilling has been completed yesterday and the GR will be prepared by September 2024. It is expected that GR will be approved by November 2024 and thus MS- 1 will be completed by end of November 2024. They promised to submit the proposal for grant of Mining Plan immediately thereafter and the samewould be approved by the end of December 2024.

The Committee observed that the scheduled timeline for MS-1, i.e. preparation of GR is 15 months from the date of allocation. The scheduled date of completion of MS-1 is 10.01.2024; however, it has not been completed till date.

The Committee noted that the delay in granting permission for drilling in forest department is also due to fire outbreak at the MP State Government Secretariat and for such delay the Allottee may not be held responsible. The Committee also took note of the assurance given by the Allottee that GR will be prepared by September 2024 and thus MS-1 will be completed by September and MS-2,i.e Mining Plan approval will be completed by December 2024.

Based on the deliberations and the commitment by the Allottee, the Committee made the following recommendation: -

- 1. The decision on this Show Cause Notice is deferred till 31.12.2024.
- 2. The Allottee will give a written undertaking to O/o NA within 3 working days that the MS-1, i.e. GR preparation will be completed by 30.09.2024 and MS-2, i.e Mining Plan approval will be completed by 31.12.2024.
- 3. In the event the MS-2 milestone i.e Mining Plan approval is completed by 31.12.2024, the issue of MS-1 will again be put up before the Scrutiny Committee for the final decision.
- 4. However, if the MS-2 milestone is not completed by 31.12.2024, the Committee recommended for imposition of penalty in the form of appropriation of PBG as per the provision of CMDPA for MS-1 milestone.

Observations and Recommendations.

The Committee observed that the Allottee delayed in applying for permission for drilling in the forest area and due to this the permission was granted from the forest department about 1year and 8 months after the allocation of the mine while the schedule timeline for preparation of GR is 15 months only. The drilling and preparation of GR is still pending. The committee is of the view that MS-1 may have been completed if the timely action were taken by the Allottee.

The Committee finds the Allottee responsible for delay in completion of MS-1 milestone and therefore recommended for imposition of penalty in the form of appropriation of PBG as per the provision of CMDPA for MS-1 milestone.

7. GondbaheraUjheni coal mine: - M/s MP Natural Resources Private Limited (MPNRPL)

Show Cause Notice dated 09.02.2024 for delay in completion of MS-2, i.e. approval of Mining Plan and the corresponding reply dated 20.02.2024 of the Allottee were considered in the meeting.

They have obtained grant of ToR for Environment Clearance and Forest Clearance activities are in progress in fast track mode. Private land purchase for shaft sinking has been completed. They have also applied to State government for grant of Mining Lease.
	The Allottee also assured that the delay in achievement of MS-2 will not lead to delay in achievement of next milestone MS-3 within the scheduled timeline. MS-3 milestone will be achieved before 08.06.2025, i.e. scheduled date for completion of MS-3.

The Committee observed that the scheduled timeline for completion of MS-2, i.e. approval of the Mining Plan was six months from the date of allocation. The

scheduled date for completion of MS-2 was 08.12.2023 while the actual date of completion is 22.05.2024 and thus there is a delay of more than 5 months.

Based on the deliberations, reply of the Allottee and the comments of O/o NA,the Committee is of the view that the Allottee is partially responsible for the delay in completion of MS-2. However, the other agencies are also responsible. The Committee also took note of the commitment made by the Allottee that the next milestone MS-3 will be completed before the scheduled date of 07.06.2025.

The Committee made the following recommendations:-

- 1. The decision on this Show Cause Notice is deferred till 08.06.2025.
- 2. The Allottee will give a written undertaking to O/o NA within 3 working days that the MS-3, i.e. grant of EC will be completed by 08.06.2025.
- 3. In the event the MS-3 milestone, i.e. grant of EC is completed by 08.06.2025, the issue of MS-2 will again be put up before the Scrutiny Committee for final decision.
- 4. However, if the MS-3 milestone is not completed by 08.06.2025, the Committee recommended for imposition of penalty in form of appropriation of PBG as per the provision of CMDPA for MS-2 milestone.

As the Prior Allottee was having various clearances for 575 Ha area only, therefore such various clearances for 575 Ha area were vested to M/s JSPL along with the Vesting Order. The Allottee is required to conduct a DGPS survey and certification of the entire block boundary. Subsequently, all necessary clearances are to be obtained based on the certified boundary for the entire allocated block area. The Allottee is required to obtain all the clearances for the entire coal block within 51 months from the date of allocation. In the present case, the Allottee has not obtained Mining Plan approval for the entire coal block within the given timeline and they are working on the basis of the vested clearances for a part of the mine.
	M/s JSPL informed that they applied for the transfer of vested clearances. Once the vested clearances were transferred to them, they started operation on that part of the mine. They produced more than 1.0 MT coal in FY 2023-24 and they are trying to achieve PRC of 3.37 MT in FY 2024-25. M/s JSPL emphasized that Utkal C is a fully explored coal mine. As a fully explored mine, statutory clearances, including the approved Mining Plan for 575 hectares, were transferred to JSPL upon the issuance of a Vesting Order. M/s JSPL stated that the auction of fully explored mines aims to commence mining operations promptly through the transfer of statutory clearances from the Prior Allottee to the Successful Allottee under CMSP Act and it implies no necessity for a new Mining Plan approval for entire coal block.

	The Allottee also stated that out of the allocated area of 753 ha, only 575 Ha is mineable. The remaining 178 Ha area is unsuitable for mining due to low thickness of seam, environmental constraints, and cashew plantation. Hence, there is no need for approval of new Mining Plan for entire block area.
	The Allottee further added that there is an overlap of 8.122 Ha area with the boundary of Utkal D&E combined coal block. However, they stated that there is no physical overlap of allocated block boundaries of Utkal D&E with Utkal C coal mine. The DGPS surveyed block boundary is within the bounding co-ordinates mentioned in the vesting order. However, a part of the mining lease area of Utkal C is going beyond the bounding co-ordinates mentioned in the vesting order and is encroaching into the block boundary of Utkal D&E combined coal block. The boundary certification for the entire Utkal-C block has not been done by MoC till date
	The Allottee stated that despite of all these issues, a revised Mining Plan for 5.0 MT PRC was submitted by them on 05.10.2023 and the area is again restricted to 575 Ha only. However the same was rejected by CCO. The Committee asked the Allottee the date by which the revised MiningPlan will be approved. In reply, the Allottee stated that they expect that the revised Mining Plan will be approved within next 3 months.

The Committee observed that by Executing the Coal Mine Production Agreement (CMDPA), M/s JSPL agreed to the conditions stipulated in the agreement, including the requirement to achieve efficiency parameters within the specified timelines. The second milestone (MS-2) pertaining to the approval of the mining plan for the entire allocated coal block area was due on April 10, 2024. However, the Allottee has not completed the MS-2 milestone within the due date. However, the Committee also took note of the fact that based on clearances for 575 Ha area, the production has started in the mine from FY 2023-24 itself.

Based on the deliberations and the reply of the Allottee, the Committee made the following recommendations:

- 1. The decision on this Show Cause Notice is deferred for three months till 08.11.2024.
- 2. In the event the approval of the revised Mining Plan (MS-2 milestone) is achieved by 08.11.2024, the issue will again be put up before the Scrutiny Committee for the final decision.
- 3. However, if the approval of the revised Mine Plan (MS-2 milestone) is not achieved by 08.11.2024, the Committee recommended for imposition of penalty in the form of appropriation of PBG as per the provision of CMDPA for MS-2 milestone.

9. Utkal B1 and B2 Coal Mine

Show Cause Notice dated 20.03.2024 was issued for non-achievement of efficiency parameter within stipulated time pertaining to approval of Mining Plan/Project Report subject to provisions of Clause 15. The show cause notice and the corresponding reply of the Allottee were considered by the Scrutiny Committee.

Approval of Mining Plan/Project Report subject to provisions of Clause 15 ((MS-2) Due Date : 10.04.2023 Actual Date :	The Office of Nominated Authority informed that Utkal B1 and Utkal B2 coal mines were allocated to M/s JSPL as a combined block through a Vesting Order dated 10.10.2022. The combined Utkal B1 and Utkal B2 coal mines are required to be operationalized within 51 months from the date of allocation. DGPS survey and certification of the entire block boundary are to be done post-allocation. However, the boundary certification and approval of the Mining Plan for the entire allocated area is still pending.
Pending	M/s JSPL stated that the Utkal B1 and B2 coal mines were allocated as a combined block for better commercial valuation and to expedite domestic coal production.Despite initial delays and discrepancies in the boundaries as per the vesting order and DGPS survey report,they proactively proceeded on the basis of the vested clearances. Clearances which have been vested to them are for Utkal-B1 & Utkal-B2 blocks separately. Also, they took proactive steps to align the Mining Plans of Utkal B1 and B2, however, they faced challenges due to lack of cooperation from the Prior Allottee and discrepancies in the boundary data. The Prior Allottee transferred all the documents to them 2 months after the allocation.
	The Allottee informed that there were discrepancies in the boundary coordinates mentioned in the vesting order with the DGPS survey conducted by ORSAC and CMPDIL. Despite several follow up with CMPDIL, the discrepancies in the boundary issue remain unresolved. Then, they moved ahead with the submission of Mining Plan based on the approved ORSAC boundary and the same was submitted on 15.07.2023. The presentation before the MiningPlan approving committee was made on 01.09.2023 where the committee advised to submit CMPDIL certified block boundary. Due to failure in submission of the CMPDIL certified boundary of the block within the stipulated timeline, the Mining Plan proposal was rejected by the committee.
	The representative of CCO stated that due to absence of CMPDIL certified boundary coordinates of the combined blocks, the proposal for grant of Mine Plan was rejected.
	The Allottee argued that their efforts to amalgamate the Mining Plans of 2 coal blocks were voluntary and beyond the requirements of the CMDPA. They also pointed out that all milestones up to MS-4 have been met and they will soon obtain the MS-5 milestone of mine opening Permission. The Allottee also informed that the presence of a GAIL pipeline passing through the mine was not disclosed at the time of auction process of the mine. Despite these hurdles, based on the existing clearances and approvals, Mining Lease has been granted for the two blocks separately.

The Committee observed that there was delay in obtaining certified boundary coordinates of the combined blocks. The Allottee has not made due diligence before submission of proposal for approval of Mining Plan for the combined blocks.

Based on the deliberation, reply of the Allottee and comments of O/o NA and CCO, the Committee has come to the conclusion that the Allottee is responsible for failure in completion of MS-2 within the stipulated timeline. Accordingly, the

Committee recommended for imposition of penalty in the form of appropriation of PBG as per the provision of CMDPA for MS-2 milestone.

The Committee also conveyed that in case the Utkal B1 &Utkal B2 mines becomes operational within 51 months of allocation, the appropriated amount of performance bank security will be refunded back to the Allottee as per the provision of CMDPA and advised M/s JSPL to operationalise mine on best efforts basis before the scheduled timeline.

10. Manoharpur&DipsideManoharpur Coal Mine

Show Cause Notices dated 06.03.2023 and 09.07.2024 were issued for nonachievement of efficiency parameters within stipulated timeline pertaining to Forest Clearance, Environment Clearance, Opening of Escrow Account, Application for opening permission, Grant of opening permission, Deviation from scheduled production for FY 2019-20, FY 2020-21 and FY 2023-24 and the corresponding reply of the Allottee were considered by the Scrutiny Committee.

Manoharpur coal block is operational while Manoharpurdipside block is non-operational. The said Show Cause Notice and the corresponding reply were considered in the 21st meeting of the Committee held on 07/08.12. 2023 and the Allottee had then assured that Environmental Clearance and Forest Clearance will be obtained by January 2024. The EC for 16 MTPA has been granted on 05.02.2024 for combined Manoharpur&ManoharpurDipside block, FC Stage-I has been granted for Dip-side Manoharpur mine on 29.12.2023, however, FC stage-II is still pending.Approval of CTE and CTO for 16 MTPA were obtained from Odisha State Pollution Control Board on 29.02.2024 and 12.03.2024 respectively. However, M/s OCPL has produced only 8.51 MT coal against the target of 10 MT in FY 2023-24.M/s OCPL stated that the grant of combined EC for Manoharpur&DipsideManoharpur for 16 MT was delayed at MoEF&CC.Due to the substantial reduction in coal demand in the region, commercial sale of surplus coal was hampered. Therefore, in spite of capacity and preparedness for production of 10 MT, coal production was restricted to 8.51MT in the FY 2023-2024. After the grant of Environmental Clearance (EC) and CTE in Feb 2024 and CTO in March 2024, M/s OCPL is on track to meet future production schedules.
	The Allottee also assured that they will produce 13 MT coal in current financial year and they will achieve PRC of 16 MT in FY 2025-26 in line with the calendar programme of approved Mining Plan.

	M/s OCPL again reiterated that the delay in grant of EC,FC and Mine opening Permission for the combined blocks was
	beyond their control and for these delays they are not responsible. The Escrow Account for Manoharpur mine was opened in October 2017 and agreement signed in December
	2017 and the same Escrow account is now operative for both the coal blocks.
	The Allottee stated that they produced 1.002 MT coal in FY 2019-20 against the target of 1.00 MT. The shortage in coal production in FY 2020-21 was mainly due to Covid-19 Pandemic.
	Regarding shortfall in production in FY 2023-24, the Allottee stated that the reasons are such constraints which are beyond their control. Therefore, the Allottee requested for not imposing any penalty on them in respect of the said
	Show Cause Notices.

The Committee observed that the combined Mining Plan for both the coal blocks for 16 MT annual capacity was approved on 26.09.2019, i.e., with delay of nearly 9 months from the scheduled date of approval of Mining Plan of Manoharpurdipside. The Committee also noted that due to delay in grant of EC and FC of ManoharpurDipside Block, the scheduled coal production was not much affected over the years mentioned in the Show Cause Notice and they achieved the scheduled production in FY 21-22 & FY 22-23 and committee to achieve the schedule production of 13 MT in FY 24-25.

Based on the deliberations and the assurance of the Allottee, the Committee made the following recommendations:-

- 1. The Committee recommended for deferring the decision on these Show Cause notices till March 2025.
- 2. In case 13 MT coal is produced in FY 2024-25 as assured by the Allottee, these issues will again be put up to the Scrutiny Committee for the final decision.
- 3. However, if the commitment for production of 13 MT is not achieved in FY 2024-25, the Committee recommended for imposition of penalty in form of appropriation of PBG as per the provision of CMDPA for the above mentioned milestones.

11. Radhikapur (West) Coal Mine

Show Cause Notice dated 06.06.2024 was issued for non-achievement of efficiency parameter within stipulated time pertaining to Forest Clearance Stage -II, and Environment Clearance. The show cause notice and the corresponding reply of the Allottee were considered by the Scrutiny Committee.

Due Dates - Forest ClearanceStage -II Environment Clearance	Office of the Nominated Authority stated that the Radhikapur (West) coal mine has been vested to M/s Vedanta Limited on 03.03.2021. As per CMDPA, the completion time for obtaining Forest Clarence (FC) and Environmental clearance (EC) is 18 months from the previous milestone, i.e, by 03.09.2022 as the Mining Plan was vested to M/s Vedanta Limited. The EC was obtained on 23.01.2023 with a delay of 4 months and FC stage 2 is yet to be obtained. It is pertinent to mention that FC Stage-1 was granted on 06.01.2022. The compliance of the conditions mentioned in FC Stage- I and in the DFO's report dated 24th Feb 2023 has not been completed by M/s Vedanta Ltd.
	The Allottee stated that there were discrepancies in Boundary Coordinates with an adjacent coal block. After several joint meetings, this issue was clarified on 8th February 2022.The Allottee stated that although the mine was vested on 3rd March 2021, the finalization of their boundary coordinates occurred only on 8th February 2022. Therefore, compliance of the milestones began only after this boundary clarification. However, Office of the Nominated Authority Stated that till date M/s Vedanta has not requested MoC for revision of the Zero date.
	The Allottee stated that they applied for transfer of EC on 8th April 2021. Since FC Stage I was not vested, they had to obtain it, which was granted on 6th January 2022. Consequently, they approached MoEF&CC, which instructed them to apply for a fresh TOR as the earlier EC had lapsed. After receiving boundary clarification on 8th February 2022 and completing all necessary studies, they approached MoEF&CC, received the fresh TOR on 8th September 2022, and the EC was granted on 23rd January 2023. The Allottee also emphasized that as per CMDPA, only the EC and not FC stage-II is a milestone for penal action in case of failure in completion within the scheduled timeline.
	The Allottee stated that the Forest Clearance Stage I proposal faced delays due to deferrals and additional conditions, with final approval granted on 6th January 2022. A part of the vested CA land was not acceptable to MoEF&CC and therefore they have to arrange fresh CA land. Additionally, concerns were raised about the impact of mining in the coal block on an elephant corridor. All these issues delayed the approval of FC stage-I.
	The Allottee also assured that they will cover up the delay in approval of FC stage-II and will operationalize the mine within the scheduled 51 months timeline given in CMDPA.

The Committee observed that due to initial confusion about the boundary coordinates of the mine and rearrangement of a part of CA land, there was delay in completion of this milestone. The issue of EC and FC stage-II matter was

considered in detail. The Committee also took note of the fact that despite the delay in achievement of this milestone, the Allottee has confirmed that the mine will be operationalized within the scheduled 51 months timeline given in CMDPA, i.e by 03.06.2025.

Based on the deliberations and the assurance of the Allottee, the Committee made the following recommendations:-

- 1. The Allottee will give an undertaking in next 3 days to O/o NA that they will operationalize the mine before the scheduled timeline, i.e by 03.06.2025.
- 2. In the event the operationalization of the mine happens on or before the due date, the matter will be put up to the Scrutiny Committee for the final decision on the Show Cause Notice for MS-3.
- 3. However, in the event the mine is not operationalized by 03.06.2025, the Committee recommended for imposition of penalty in the form of appropriation of PBG as per the provision of CMDPA.

12. Utkal -A Coal Mine

Show Cause Notice dated 06.06.2024 was issued for non-achievement of efficiency parameter within stipulated time pertaining to Environment Clearance. The show cause notice and the corresponding reply of the Allottee were considered by the Scrutiny Committee.

Environment Clearance(MS-3) Due date: 24.06.2023	Office of the Nominated Authority stated that Utkal A coal mine has been allotted to M/s Mahanadi Coalfields Limited (MCL) vide Allotment Order dated 18.11.2021 . Utkal A coal mine is a fully explored coal mine and therefore MS-1 is not applicable. The stipulated timeline for completion of MS-2, approval of Mining Plan is 6 months from the date of allocation i.e., by 18.05.2022. The Mining Plan was approved by the Board of Director of MCL on 27.12.2021 itself before the due date. Further, as per efficiency parameters stipulated in the Allotment Agreement of Utkal A coal mine, MS-3 has to be obtained within 18 months from completion of previous milestone i.e., by 24.06.2023. However, the EC was obtained on 06.03.2024 after a delay of about 8 months from the scheduled timeline.
	M/s MCL informed that Utkal-A Coal Mine had a six-month period from 18.11.2021 to 17.05.2022 to complete MS-2. By taking proactive measures, they obtained approval for the Mining Plan on 24.12.2021, which was 4 months and 24 days ahead of the scheduled timeline. They have obtained EC on 06.03.2024 while the scheduled date is 18.11.2023 as per Allotment agreement and therefore, the delay is only of 3 months and 18 days and not the alleged 8 months and 11 days. Even this delay is not on account of them. The Allottee further stated that the earlier approved TOR condition conflicted with the excavation plan of Utkal-A Coal Mine which required the stream's diversion for overburden dumping. The EAC did not consider the significant impacts this would have on the Mining Plan, coal reserve, stripping ratio, and mine economics. Consequently, they requested a modification of this ToR condition from MoEF&CC on 10/11.12.2021, and the final ToR with the necessary modifications was obtained on 28.02.2022. This

resulted in a delay of 3 months and 6 days, which was beyond their control.
Further, MoEF&CC raised 10-points EDS on 27.02.2023, necessitating minor modifications to the Mining Plan. The modified Mining Plan was approved and received on 16.05.2023. The EIA/EMP report and modified Mining Plan were submitted to State Pollution Control Board (SPCB) for Public Hearing on 05.06.2023.Despite continuous follow-up, the Public Hearing was held 81 days after the submission of application. The Allottee further informed that due to some technical glitches in Parivesh-2.0 portal, there was delay in uploading of the application for grant of EC. All these delays were beyond their control.
The Committee inquired from the Allottee about the status of the next milestone, i.e MS-4, related to land possession. The Allottee informed that they have acquired 1100 Ha land, however, only 307 Ha land is in their possession. Rise side land from where mining is to start is still not available with them. They are continuously trying to possess sufficient land for starting the mining activity. On being inquired by the Committee, the Allottee assured that they will have in possession sufficient land for achieving the PRC by the

Based on the deliberations and the assurance of the Allottee, the Committee made the following recommendations:-

- 1. The Allottee will give an undertaking in next 3 days to O/o NA that they will complete the MS-4 Milestone before the scheduled timeline, i.e by 24.03.2025 as per the Allotment agreement.
- 2. In the event MS-4 Milestone is completed on or before the scheduled date, the matter will be put up to the Scrutiny Committee for the final decision on the Show Cause Notice for MS-3.
- 3. However, in the event MS-4 Milestone is not completed on or before the scheduled date, i.e by 24.03.2025, the Committee recommended for imposition of penalty in the form of appropriation of PBG as per the provision of Allotment Agreement for failure in completion of MS-3 within the scheduled timeline.

13. East of Damagoria (Kalyaneshwari) Coal Mine

Show Cause Notice dated 04.06.2024 was issued for non-achievement of efficiency parameter within stipulated timeline pertaining to Possession of land and R&R to reach rated capacity as per approved Mining Plan and Mine Opening Permission. The Show Cause notice and the corresponding reply of the Allottee were considered by the Scrutiny Committee.

	M/s BCCL informed that Forest clearance is not applicable to them as there is not any forest within the area of the approved Mining Plan of the coal block. Accordingly, mining activity was commenced by BCCL in the block and continued even subsequent to signing of Allotment Agreement on 26.09.2019. Hence, there is no requirement for obtaining Mine Opening Permission for commencement of production from the block.
	Additionally, M/s BCCL stated that, the allocation of the Kalyaneshwari coal block to BCCL initially faced challenges due to overlapping lease areas with the adjacent Sitarampur block, totaling approximately 55.18 Ha. Despite ongoing efforts through correspondence and meetings, resolution of these boundary issues delayed the finalization of the Kalyaneshwari Block Project Report. To address these obstacles, the Nominated Authority directed the revision of boundary coordinates and the merging of the northern part of the Sitarampur block with Kalyaneshwari. Also, in consent with SAIL,decision was taken that BCCL will make DPR involving Ramnagar coal block area of SAIL. This directive resulted in a corrigendum on October 25, 2023.
	M/s BCCL stated that the geological area of the East of Damagoria coal block spans 703 Ha of land. However, M/s BCCL currently holds lease and ownership rights over only 533.14 Ha, including the land transferred from ECL to BCCL.
	The remaining 169.86 Ha are not under BCCL's lease and ownership, with a portion of this area belonging to

	SAIL and Sitarampur CMSP block. This situation has posed challenges for M/s BCCL in preparing a DPR for the entire East of Damagoria coal block. To overcome this obstacle, for 30 Ha of land, a Memorandum of Understanding (MoU) between M/s BCCL and M/s SAIL was made with provisions that mining will be done by BCCL and the coal will be utilized by SAIL. Additionally, an area of 26.19Ha is no man's land as its lease is not with any company.
	Subsequent to direction of the Nominated Authority, BCCL's Board approved a Detailed Project Report (DPR) on April 24, 2024, encompassing the East of Damagoria Coal Mine and collaborating with Ramnagar mine. M/s BCCL mentioned in its reply that the preparation of the DPR for the East of Damagoria (Kalyaneshwari) Coal Block was delayed due to unresolved boundary issues.
	M/s BCCL emphasized that the completion of time limit of activities mentioned in SCN does not tally with the Allotment Agreement. For MS-6, time line should be 60 Months (ie, due date should be 13.11.2024) and for MS- 7 time limit should be 66 Months (ie, due date should be 13.05.2025).
	The Office of the Nominated Authority asserted that M/s BCCL provided no communication to O/o NA concerning thecoal production from the East of Damagoria coal mine, resulting in the office being completely unaware of any such activities. Moreover, M/s BCCL did not submit the required production reports to Nominated Authority.

Based on the deliberation and the reply of the Allottee, the Committee concludes that at this stage it is not possible to assess whether the Allottee is responsible for the delay in these milestones. The Committee, therefore, recommended that M/s BCCL first sit together with O/o NA and resolve the issue of timeline for various milestones. Only thereafter, these matters should be put up before the Scrutiny Committee for the final decision.

14. Trans Damodar Coal Mine

Show Cause Notices dated 22.06.2023 and 23.06.2023, was issued for non-achievement of Schedule Production for year 2020-21, 2021-22 and 2022-23. The show cause notices and the corresponding replies of the Allottee were considered by the Scrutiny Committee.

Allottee mentioned that there was a dispute regarding encroachment of Rayati land through mining activities done by the prior allottee and subsequent water logging on the un-purchased land led to unrest by the adjacent villagers.
	The Allottee further stated that there are three factories namely M/s Sonic Thermal Pvt Ltd. M/s Eurasia Industries Ltd and M/s Extrusion (1985) pvt Ltd lying inside the mine boundary. Due to this, the progress of mining activity towards western side of coal mine was prohibited. They approached District Magistrate for the acquisition of the factories, however the owners didn't respond to District Authority.
	Further, M/s DPL required 970 acre of land for TDCM project, but, they are having only 390 acre land.Further purchase of land is under process with the help of local administration. TDCM is situated in densely populated area in close vicinity of Durgapur Municipality. Villagers are not willing to lose their land. They have taken different approach for purchase of land through Dept of Power of Govt of west Bengal.
	The Allottee also stated that the State government is well aware of the difficulties faced by them in achieving the scheduled production from FY 20-21 to FY 22-23 and comment of the state government may be sought on the issue before taking final decision. The Allottee further requested the Committee to give some time to obtain comment of the state government on the issue.

The Committee observed that about 6%, 51 % and 55 % of the target production was achieved in FY 20-21, FY 21-22 and FY 22-23 respectively. The committee also noted that PRC of 1.0 MT was achieved in the FY 23-24.

Based on the deliberation and the assurance of the Allottee, the Committee decided to seek the comment of the State government on the issue of the difficulties faced by the Allottee in achieving the target production for the above mentioned periods before making final recommendation. Therefore, the Committee made the following recommendation:-

- 1. The Committee asked the Allottee to submit the comment of the state government regarding the said issue within a month to O/o NA. In case of failure of submission of the comment of the state government within one month, it will be assumed that the state has no comment to make and then the committee will decide accordingly. However, in case the comment of state is received within the given timeline, the issue of shortage in coal production in FY 21-22 and FY 22-23 will be considered in the next meeting for final decision.
- 2. Regarding shortage in coal production in FY 20-21, the Committee observed that the production is only 6 % of the target and Committee also took note of the statement of the Allottee that production was also affected due to Covid-19 pandemic as there was lockdown for 6 months in the state of West Bengal. The Committee recommended that in case the comment of the state government is received within a month, the issue will be considered in the next meeting for final decision, however, in case of failure of submission of the comment of the state government within one month, penalty in form of appropriation of PBG will be imposed as per the provision of CMDPA.

15. DeochaPachamiDewanganjHarinsingha Coal Block:-West Bengal Power Development Corporation Ltd. (WBPDCL)

The Deocha-PachamiDewanganj-Harisingha coal block has been allocated to M/s. The West Bengal Power Development Corporation Ltd. (WBPDCL). Following the allocation of the Deocha-Pachami-Dewanganj-Harinsingha Coal Block, it was noted that there was a discrepancy between the resources allotted by the Ministry of Coal (MoC) and those available within the block boundary. To address this, it was necessary to annex an additional area to the eastern side of the block. The original area of 9.70 sq. km mentioned in the agreement only covered the Deocha-Pachami section and did not include the Dewanganj-Harinsingha portion.

To rectify this, a draft amendment agreement was sent to WBPDCL on 7th October 2020, with follow-up reminders issued on 29th December 2020, 22nd February 2021, 6th April 2021, 10th June 2021, 9th September 2021, 27th December 2021, and a DO letter on 17th February 2022. WBPDCL confirmed on 22nd February 2022 that necessary approvals from the State Government had been obtained. The amendment agreement was eventually signed by WBPDCL on 28th March 2022.

WBPDCL has informed that delay in completing drilling and exploration by the initial deadline of 15th August 2020 was due to the fact that bounding coordinates were only finalized after the execution of the amendment agreement. WBPDCL appointed M/s. CMPDIL for detailed coal exploration and preparation of the Geological Report and Mining Plan on 13th January 2022, subsequent to the allotment agreement but prior to the amendment agreement. The block area was subsequently expanded after the amendment agreement.

Observation & Recommendation: - After a comprehensive examination of the case, the Committee recommended that the date of signing of the 1st Amendment to the Allotment Agreement, which is 28th March 2022, should be considered as

the zero date. All milestone dates associated with the Coal Block will be redefined using the aforementioned zero date. Accordingly, the revised milestone dates will be compiled and presented for discussion at the subsequent Scrutiny Committee meeting.

16. Brinda and Sisai Coal Mine -M/s Dalmia Cement (Bharat) Limited (DCBL)

Show Cause Notice dated 25.04.2024 for non-compliance with Milestone MS-2 for approval of Mining Plan/Project report and corresponding reply of the Allottee dated 08.05.2024 were considered in the meeting. The Allottee was given opportunity to present its case before the Committee.

In reply, the Allottee stated that the area of the geological block lying outside the leasehold area is non-coal bearing and no working or infrastructure is proposed in this area and therefore revision of Mining Plan is not required. They also mentioned that area of the coal block is not 1974 ha as stated by O/o NA. The O/o NA advised the Allottee to submit a copy of CMPDIL certified DGPS survey report at the earliest. The Committee inquired from the Allottee whether they would be able to submit the certified copy of the DGPS Survey from CMPDIL within 60 days.The Allottee assured that they would obtain the certified DGPS Survey

Observation & Recommendation: -

The Committee is of the opinion that the entire Geological Block area should be fully projectized. The Committee also observed that the scheduled timeline for the Approval of Mining Plan/Project report is 6 months from the date of allocation, i.e., 10.10.2022; however, it has not been completed till date. O/o NA and the Allottee differed on the issue of the total geological block area and this can only be decided on the basis of DGPS survey of the entire block boundary. The Committee also took note of the fact that the Allottee has given assurance that they will obtain certified DGPS Survey within 60 days.

Based on the reply of the Allottee and deliberations in the meeting, the Scrutiny Committee decided for deferring the decision on MS-II milestone till the time of certification of block boundary based on certified DGPS survey report. The Committee made the following recommendations:

- 1. The Allottee will give an undertaking that they will submit the certified copy of the DGPS survey report of the geological block within 60 days.
- 2. Based on the DGPS survey report, the area of the geological block will be finalised. Thereafter, the issue will be put up before the Scrutiny Committee for final decision in the next meeting of the committee.

17. Basantpur Coal Mine: - M/s Gangaramchak Mining Private Limited (GMPL)

Show Cause Notice dated 02.04.2024 for non-compliance with Milestone (MS-1), which consists of Preparation of Geological report and the corresponding reply of the Allottee dated 15.04.2024 were considered in the meeting. The Allottee was given opportunity to present its case before the Committee.

The Committee observed that the scheduled timeline for MS-1 milestone regarding the Preparation of Geological report is 15 months from the date of allocation. The date of allocation is 12.12.2022 while the due date for completion of MS-1 is 12.03.2024; however, it has not been completed till date. The Committee observed that there was some delay on part of the State government and it also took note of the fact that the Allottee has assured that MS-1 will be completed by 28.02.2025.

Based on the reply and assurance of the Allottee and the deliberation that took place, the Committee is of the view that some extra time may be given for completion of MS-1 milestone and decided to defer the decision on MS-1 milestone. The Committee, further, made the following recommendations:

- 1. The Allottee will give written undertaking to O/o NA declaring that they will complete the MS-1 milestone by 28.02.2025
- 2. In the event the MS-1 is completed by 28.02.2025, the said issue will again be considered in another meeting of the Committee after the above given date.
- 3. However, in the event the said milestone is not achieved by 28.02.2025, the Committee recommended for imposition of penalty in the form of appropriation of PBG as per provision of CMDPA without again referring the matter to the Scrutiny Committee.

18. Rauta Closed Coal Mine: - M/s Shreesatya Mines Private Limited (SMPL)

The Committee observed that the scheduled timeline for MS-1,i.e., preparation of GR is 15 months from the date of allocation; however, it has not been completed till date. As per the CMDPA, in case the GR is prepared after 15 months up to 24 months from date of allocation, 25 % of PBG is to be appropriated and in case GR is prepared after 24 months, additional 25 % of PBG is to be appropriated.

The Committee is of the view that the Allottee seems to be responsible for the failure in preparation of GR within 24 months from the date of allocation. However, the Allottee has also given assurance that MS-I, i.e., GR preparation and approval will be completed by 31.05.2025 and they will submit the undertaking regarding this within three days.

Based on the deliberations during the meeting and the assurance of the Allottee, the Committee recommended for deferring the decision on the issue till 31.05.2025. The Committee further recommended that In the event the MS-I regarding GR preparation and approval is not completed by 31.05.2025, the penalty in the form of PBG appropriation as per CMDPA will be imposed and in case the MS-I is completed by 31.05.2025, the matter will again be considered by the Committee for further decision.

19. Parbatpur Central Coal Mine: - M/s JSW Steel Limited (JSWSL)

Show Cause Notice dated 02.04.2024 for delay in achievement of Milestone which consists of Completion of transfer of statutory permissions obtained by prior allottee/obtaining fresh statutory permissions, if required and opening of Escrow Account and corresponding reply of the Allottee dated 16.04.2024 were considered in the meeting.

Based on the deliberations during the meeting and the assurance of the Allottee, the Committee recommended for deferring the decision on opening of Escrow account and transfer of statutory permissions. The Committee further recommended the following:

- I. In case the milestone of opening of Escrow account is opened by 15.09.2024, the matter will again be considered by the Committee for further decision, however, in case this milestone of opening of Escrow account is not completed by 15.09.2024, the penalty in the form of PBG appropriation as per CMDPA will be imposed.
- II. The Committee also recommended that in case the statutory permissions are completed by 31.03.2025, the matter will again be considered by the Committee for further decision. However, in case the statutory permissions are not completed by 31.03.2025, the penalty in the form of PBG appropriation as per CMDPA will be imposed on 01.04.2025.

20. Rohne Coal Mine- NMDC Limited

Show Cause Notice dated 04.06.2024 issued for non-compliance with timeline of below mentioned Milestone specified in Schedule E of Allotment Agreement of Rohne coal mine and the corresponding reply of the Allottee were considered in the meeting. The representative of the state government and the Allottee also put up their views on the issues before the Committee.

Based on the facts presented by the Allottee and O/o NA, the Scrutiny Committee recommended that M/s NMDC would submit an undertaking to the Ministry of Coal within 3 working days to the effect that they will complete Milestone No. MS-4 by 27.11.2025 i.e. 18 months from date of rejection of NMDC's request for modification of CA land condition to raise CA over degraded forest land by MoEF& CC.

The Committee recommended that till 27.11.2025, the imposition of penalty for delay in achievement of MS-4 will be put on hold. The Committee further recommended that in the event MS-4 Milestone is not achieved by 27.11.2025, there will be imposition of penalty in form of appropriation of PBG as per provision of CMDPA for MS-4 without referring the matter to the Scrutiny Committee. The Committee observed that based on comment of CMPDIL, O/o NA had informed Allottee that there was not any need to change the bounding coordinates of the coal block and the bounding coordinates given in the Allocation order will remain the same. In view of this, the Allottee should have initiated the process for grant of EC, FC and Mining Lease; however, they have not even applied for grant of these clearances. The Committee is also of the view that JSMDCL should have done DGPS survey of the block in the beginning itself for fixation of the boundary of the coal block, however, they have delayed in obtaining DGPS survey report for the geological boundary of the coal block.

Based on the reply of the Allottee, comment of O/o NA and detailed deliberation, the Committee concludes that the delay in instant case is only attributable to the Allottee and therefore, the Committee recommended imposition of penalty in the form of appropriation of PBG as per provision of CMDPA for delay in achievement of Milestone No. MS-3B,MS-4 and MS-5.

22. Bhaskarpara Coal Mine- Prakash Industries Limited (PIL)

Show Cause Notice dated 09.05.2024 was issued for delay in completion of MS-3 Milestone of "Environment Clearance" specified in Schedule E of Coal Mine Development and Production Agreement (CMDPA) of Bhaskarpara coal mine and the corresponding reply of the Allottee were considered in the meeting.

The issue of delay in the grant of the Mining Lease and Possession of land & R&R were deliberated upon. The Committee took note of its earlier decision taken in the 19th and 21st Scrutiny Committee meeting wherein penalty had been imposed upon KPCL for non-compliance with timeline of Milestone of FC-I, FC-II and EC and made observation that the EUPs linked with the coal block is not ready and KPCL is not sure whether this EUP will ever be constructed or not.

The Committee also took note of the fact that the representative of the state government did not agree with the reasons for the delay given by the Allottee and they also found Allottee responsible for the delay.

Despite the reasons provided by the Allottee for the delays in grant of Mining Lease and possession of land, the Committee is of the view that the Allottee themselves are mainly responsible for not achieving these milestones within given timeline.

Based on the comment of the Allottee, representative of State government and O/o NA, the Committee has concluded that the Allottee themselves are responsible for non-achievement of Milestone MS-5 and MS-6. Accordingly, the Scrutiny Committee recommended for imposition of penalty in the form of appropriation of PBG as per provision of CMDPA for delay in achievement of Milestone No. MS-5 and MS-6.

Based on the deliberations, written reply of the Allottee and the comment of O/o NA, the Committee has come to the conclusion that M/s JPL itself is mainly responsible for failure in timely completion of MS-2 milestone. The Committee, therefore, recommended for imposition of penalty in the form of appropriation of PBG as per provision of CMDPA for MS-2 for failure in obtaining Mining Plan approval within the given timeline.

26. Datima Coal Mine- Shree Cement Limited (SCL)

Show Cause Notice dated 09.02.2024 was issued for non-compliance with timeline of Milestone MS-2 for "Mining Plan approval" in respect of Datima coal mine. The corresponding reply of the Allottee was considered in the meeting. The representative of the M/s Shree Cement Ltd. put up their views before the Committee.

Accordingly, the Committee noted that taking into consideration the due date for MS-2, i.e., Mining Plan Approval as 07.12.2023 and allowing normative period of 18 months for MS-3, the scheduled date for achievement of MS-3 Milestone works out to be 07.06.2025. The Committee also took note of the assurance of the Allottee that they will give undertaking to O/o NA to achieve MS-3 by 07.06.2025 as per CMDPA within 3 working days.

Based on the deliberations, written reply of the Allottee and the assurance of the Allottee for timely achievement of next milestone, the Committee decided to put on hold the decision on Show Cause Notice for MS-2, i.e., Mining Plan Approval. The Committee further recommended that in the event next milestone i.e. MS-3 is achieved by 07.06.2025, the issue of Show Cause notice for MS-2 Milestone will again be put up before the Scrutiny Committee for a decision. However, in the event MS-3 Milestone is not achieved by 07.06.2025, the Committee recommended for imposition of penalty in the form of appropriation of PBG as per provision of CMDPA for MS-2 without referring the matter to the Scrutiny Committee.

Based on submissions made by the Allottee, office of NA and representative of the State Government, the Committee recommended that the date of Central govt's notification i.e. 07.03.2024 regarding increase in area for grant of PL should be taken as the new Zero Date for the said coal mine. Observations and Recommendations of the Committee:

Show Cause Notice dated 12.06.2024 for delay in completion of transfer of statutory permissions obtained by Prior Allottee and opening of Escrow Account were issued. The due date for completion of the above mentioned milestones is 17.05.2024, however, completion of this listed milestones is still pending. During the discussion it was observed by the Scrutiny Committee that the Allottee submitted a Mining Lease application for 194.68 Ha area while the vested Mining Plan was of only 133.65 Ha area. The Committee also acknowledged the fact that the vested Mining Plan does not include mine closure plan and this delayed in applying for opening of Escrow Account.

After considering the above facts, the Committee recommended that the Allottee may be provided with additional time for completion of statutory clearances and opening of Escrow Account.

Based on the assurance of the Allottee for completion of all clearances in next 6 months, the Committee recommended for giving 6 additional months for completion of all clearances from the due date(17.05.2024) for completion of milestone as per CMDPA. The Allottee also agreed that they will achieve all clearances by 17.11.2024.

The Committee directed the Allottee to give an undertaking to the Nominated Authority within three working days declaring that they will complete the said milestone by 17.11.2024. The Scrutiny Committee further recommended that in the event the above mentioned milestone is achieved by 17.11.2024, the issue will again be put up before the Committee for a decision. However, in the event the said milestone is not achieved by 17.11.2024, the Committee recommended for imposition of penalty in form of appropriation of PBG as per provision of CMDPA without again referring the matter to the Scrutiny Committee.

30. MarkiMangli II -M/sYazdani International Private Limited (YIPL)

Show Cause Notice dated 18.06.2024, for delay in completion of MS-3 Milestone related to Forest Clearance, Wildlife Clearance and Environment Clearance and the corresponding reply of the Allottee were considered by the Scrutiny Committee.

Public Hearing and final EIA/EMP report have been completed. However, the final EIA/EMP report and Public hearing minutes have not been submitted as Forest Clearance Stage-I is still pending.
	The Allottee further informed that the Forest Clearance application was recommended by the Government of Maharashtra to the MoEF&CC on 02.08.2023, and the proposal for FC Stage-I for MarkiMangli-II was presented at the Forest Advisory Committee (FAC) meeting on 30.04.2024. They mentioned that the delay was partly due to the late submission of the Regional Officer's (RO) report. The Allottee also stated that they are unable to proceed with other clearances due to pending FC Stage-I.
	The Nodal Officer & APCCF, Nagpur stated that FC Stage-I would have been granted during the FAC meeting on 30.04.2024, but the Allottee requested a 20% relaxation in Compensatory Afforestation (CA) land, as the CA land was adjacent to an eco-sensitive zone. The MoEF&CC asked the Regional Officer to verify and submit a report, which has been done, and FC Stage-I approval is now expected during the next FAC meeting scheduled for 27.08.2024.
	The Nodal Officer also informed that M/s YIPL registered on the Parivesh portal on 31.07.2021 but took 10 months to submit the

	required documents for Stage-I diversion, which they submitted on 23.05.2022. EDS was raised and compliances submitted in December 2022. Despite this, there was an overall delay of 18 months in submitting the necessary documents for the FC Stage-I application. Once the application was forwarded to the MoEF&CC, another EDS was raised in January 2024 by MoEF&CC. M/s YIPL further delayed in submission of the compliance report to the MoEF&CC. Due diligence has not been done by the Allottee in submission of application which is complete in all aspect for FC stage-I and this led to the delay in grant of FC stage-I.

Observations and Recommendations of the Committee:

Show Cause Notice was issued for failure in achievement of MS-III (Forest Clearance (Stage-I & Stage-II), Wildlife Clearance & Environmental Clearance). The Committee observed that the due date for completion of the MS-III milestone is 13.04.2024, however, it is still pending. During the discussion it was observed that due diligence was not done by the Allottee in submission of application for FC Stage-I which is complete in all aspect and this led to issuance of EDS at different levels. The Committee also noted that the time required for normal administrative procedures are already factored into the timeline given for various milestones in the CMDPA. It is the responsibility of the Allottee to submit application along with all requisite documents and do proper follow-ups. Committee also took note of the statement of the official of State Forest department who didn't endorse the comment made by the Allottee.

Based on the reply of the Allottee and comment of O/o NA and State government official, the Scrutiny Committee is of the view that the Allottee is responsible for non-achievement of MS-III within the Scheduled timeline. Accordingly, the Committee recommended for appropriation of Performance Bank Guarantee for failure in achievement of MS-III as per the provisions of CMDPA.

31. Kalyanpur-Badalpara Coal Block:-M/s. Haryana Power Generation Co. Ltd. (HPGCL)

The Kalyanpur-Badalpara Coal Block has been allocated to M/s. Haryana Power Generation Co. Ltd. (HPGCL). Following the allocation of the Kalyanpur-Badalpara Coal Block in 2016, HPGCL faced difficulties in commencing drilling activities due to law & order issues. On 19th October 2020, HPGCL requested the termination of the Coal Block Development and Production Agreement (CBDPA) due to an Extended Force Majeure condition and sought the release of Bank Guarantee of Rs 15.015 Crore. The request of HPGCL was forwarded to state government for comments which are awaited.

Subsequently, apolicy allowing government companies a one-time opportunity to surrender non-operational coal blocks without penalty was approved on 7th April 2022. HPGCL submitted a surrender request on 26th August 2022. However, their request was not within the amnesty scheme's window period (9th May 2022 to 8th August 2022) and was thus not considered. This was communicated to HPGCL on 12th December 2022.

On 10th July 2023, HPGCL withdraw their previous surrender plea and requested that they may be allowed to make another attempt to develop the Kalyanpur-Badalpara coal block and requested an extension for the timeline of activities specified in Schedule-IV-A of the CBDPA. Ministry of coal agreed to their request on condition that milestone should be achieved. However, no update of further development of the block has been received from HPGCL.

Observation & Recommendation: The allottee did not attend the meeting.

Consequently, the Committee has deferred the case of HPGCL to the next meeting

for further consideration.

32. Kente Extension Coal Block:-M/s RajsthanRajyaVidyutUtpadan Nigam Ltd.(RRVUNL)

The Kente Extension Coal Block was allocated to M/s RRVUNL on 31.03.2015, with the Coal Block Development and Production Agreement (CBDPA) signed on 26.10.2015 and the first amendment on 10.08.2016. The 15th Scrutiny Committee meeting discussed these issues and found that while delays in obtaining the prospecting license was not on the part of RRVUNL's fault, there were delays in the preparation of the Geological Report (GR) and submission of the Mining Plan. Accordingly, BG was appropriated as recommended by the scrutiny committee. The allottee contends that, delays in granting of PL and due to COVID-19, other milestones have also been delayed which would have been otherwise achieved, there would be no further delays or only minor delays in other milestones.

Observation & Recommendation: -During the 24th Scrutiny Committee meeting, representative of the Government of Chhattisgarh, confirmed that the delays cited by the allottee were valid. These delays were attributed to local resistance, law and order issues, and opposition from activists related to the Hasdeo Forest. Given these circumstances, the Committee concluded that the allottee should not be held responsible for these delays and recommended towaive off the appropriation of the Bank Guarantee (BG) for delay in Mining Plan approval, Previous approval, FC application, EC application & grant of Mining Lease.

For pending milestones i.e. Forest Clearance, Environment Clearance, Land Acquisition, Opening of Escrow account, Application for opening permission, Grant of opening permission, the decision on BG appropriation is deferred until 31.03.2026. The allottee must provide an undertaking to the Ministry of Coal that all activities would be completed by 31/03/2026. The matter will again be reviewed by the Scrutiny Committee after 31/06/2026.
