### Monthly Summary for the Cabinet for the month of September, 2024 in respect of Ministry of Coal

#### 1. Principal Activities

The core objectives of the Ministry of Coal are to augment coal production by adopting state-of-theart clean-coal technologies; enhancing exploration efforts with thrust on increasing proven coal resources and developing necessary infrastructure for prompt evacuation of coal for securing its availability to meet the demand of different sectors of the economy in an eco-friendly and sustainable manner.

#### 2. Coal production, dispatch and supply for the month of September, 2024 are as under:

- i. Overall domestic coal production in the month of **September**, 2024 was 68.95 MT as against 67.261 MT in the month of **September**, 2023, registering growth of about 2.51%. It includes coal production of 50.94 MT by ClL, 3.747 MT by SCCL and 14.263 MT by Captive & Other mines (Provisional).
- ii. Overall domestic coal dispatch in the month of **September**, 2024 was 73.529 MT as against 70.249 MT in the month of **September**, 2023, registering growth of about 4.67%. It includes dispatch of 54.40 MT by ClL, 4.222 MT by SCCL and 14.907 MT by Captive & other mines (Provisional).
- iii. Overall domestic coal supply to Power Sector in the month of **September**, **2024** by CIL and SCCL was **48.72** MT as against **50.46** MT in **September**, **2023** (Provisional).

#### 3. Steps taken for sustained production of coal:

- i. Production of coal from captive coal blocks in September, 2024 is 11.769 Million Tonnes (Provisional), out of which, aggregate coal production of those coal blocks which have not been cancelled by the Hon'ble Supreme Court viz. PakriBarwadih(1.419 MT), Tasra(0.050 MT) and Moher & Moher Amlori Extn. (1.426 MT) is 2.895 Million Tonnes (Provisional).
- ii. Coal production in the month of September, 2024 from captive/commercial mines is 13.74 MT and revenue worth Rs. 221.74 crores has gone to State Government(s) during the month of September, 2024
- iii. 01 Vesting Order under CM (SP) Act, 2015 and 02 vesting Orders under MMDR Act, 1957 have been issued by Nominated Authority in the month of September, 2024.

#### 5. Drilling in Coal and Lignite:

Promotional Drilling in FY 2024-25: As per the approved BE for Promotional drilling in FY 2024-25, 2.0 lakh meters of drilling in coal/lignite has been envisaged in the Annual Plan of CMPDI. As against this, the achievement of drilling upto the month of Sep.'2024 is 0.894 lakh metre, against the target of 0.877 lakh metre, which is 102% of the target.

Overall Progress of Detailed Drilling in FY 2024-25: Annualplan target of 10.0 lakh metre of drilling (Departmental: 4.20 lakh metre, Outsourcing: 5.80 lakh metre) has been kept. As against this, 3.825 lakh metre of drilling has been carried out upto the month of Sep. '2024 against the target of 3.825 lakh metre, which is 100% of the target.
