FINAL COMPENSATION ORDER

Subject:

Final Determination of Compensation for Geological Report, Consents, Land, and Mine Infrastructure Payable to M/s Jharkhand State Mineral Development Corporation Limited (JSMDC) with respect to Rabodiha OCP coal mine, in accordance with the Coal Mines (Special Provisions) Act, 2015, and Judgment dated March 09, 2017, of the Hon'ble Delhi High Court.

In pursuance of the Provisional Compensation Order issued on October 14, 2024, the prior allottee, M/s Jharkhand State Mineral Development Corporation Limited (JSMDC), and the successful allottee, M/s Twenty First Century Mining Private Limited (TFCMPL), were invited to present their comments or objections, if any, regarding the determination of the compensation amount by the Nominated Authority. The meeting was scheduled for October 24, 2024, at 12:00 noon.

- 2. Accordingly, prior and successful allottees attended the meeting on October 24, 2024 (List of participants is at Annexure-I) and accepted the compensation as determined in provisional compensation order by Nominated Authority. Additionally, both parties submitted written acceptance of the compensation for the cost of the Geological Report, Consents, Land, and Mine Infrastructure via letters dated October 23, 2024, and October 17, 2024, respectively, and requested the Nominated Authority to expedite the disbursement of the compensation. M/s TFCMPL also requested the handover of the original geological report.
- 3. In view of the above, M/s JSMDC is directed to hand over the original Geological Report to the successful allottee, M/s TFCMPL, within 15 days of receipt of this order. The compensation amount of ₹14,19,17,416/- as determined in the Provisional Compensation Order dated October 14, 2024, is hereby finalized in respect of the Rabodiha OCP Coal Mine.
- 4. In accordance with section -27 of the Act and the judgement dated 09.03.2017, it is open to M/s Jharkhand State Mineral Development Corporation Limited and

M/s Twenty First Century Mining Private Limited to raise disputes with regard to the quantum of compensation before the Tribunal constituted under the Coal Bearing area (Acquisition and Development) Act 1957.
