@ A provision of ₹ 730 crores kept at BE 2024-25 for Central Sector Scheme of Exploration of Coal & Lignite and it will be met through NMET funds (through recovery).

During the financial year 2023-24; ₹ 604.9495 crores was utilized against the allocation of ₹ 619.04 crore at RE. The un-utilized amount in financial year 2023-24 was mainly due to mandatory provisions for the North-East Region under Central Sector Schemes and reduction in overall budget allocation.

The utilization of funds during the financial year 2024-25 was ₹ 651.19 crores (upto December, 2024) against the allocation of ₹ 871.21 crores at RE stage.

For FY 2025-26, the allocation has been kept at ₹ 1251.20 crores at BE. Out of which, ₹ 1172.50 crores is allocated for Central Sector Schemes, ₹ 10.43 crore is allocated for Government contribution towards Coal Mines Pension Scheme (CMPFO), and the remaining amount of ₹ 68.27 crores is allocated for Secretariat (MoC), Nominated Authority, Coal Controller Organization.

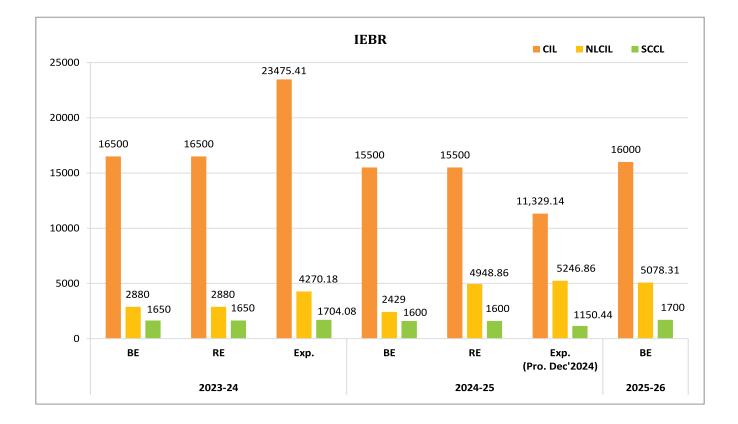
