**AUCTION OF COAL MINES FOR SALE OF COAL
NOTICE FOR REFUND OF TENDER FEE FOR COAL MINES WITHDRAWN FROM AUCTION**

(11th TRANCHE OF AUCTION UNDER THE COAL MINES (SPECIAL PROVISIONS) ACT, 2015)
(1st TRANCHE OF AUCTION UNDER THE MINES AND MINERAL (DEVELOPMENT AND REGULATIONS)
ACT, 1957)

Bidders may kindly note that the Nominated Authority, vide notices dated July 21, 2020 and September 01, 2020, had withdrawn following 6 Coal Mines from the list of mines for auction under 11th Tranche of Auction under the CM(SP) Act, 2015 and 1st Tranche of Auction under the MMDR Act, 1957:

1. Withdrawal of **Bander** Coal Mine from the 11th Tranche of Auction under the CM(SP) Act, 2015 vide notice dated July 21, 2020
2. Withdrawal of **Fatehpur East, Madanpur (North), Morga-II, and Sayang** Coal Mines from the 11th Tranche of Auction under the CM(SP) Act, 2015 vide notice dated September 01, 2020
3. Withdrawal of **Morga South** Coal Mine from the 1st Tranche of Auction under the MMDR Act, 1957 vide notice dated September 01, 2020

In view of the above, it may kindly be noted that the Nominated Authority has decided that the tender fee of Rs. 5 lakh with respect to each bid, paid by the registered Bidders for these Coal Mines shall be refunded.

Process for Refund of Tender Fee

The Authorized Signatory of the Bidder shall send an e-mail to coalblock@mstcindia.co.in mail ID with the subject line "**Request for refund of Tender Document Fee for Name of Coal Mine(s)**" from the registered mail ID and attach the following document:

1. Scanned copy of cancelled cheque
2. Duly filled bank mandate form and certified by the bank

In the said email, Bidder should also provide the details of payment made by it while remitting the tender document fee like UTR No, date of payment and amount.

Refund shall be made to the bank account whose details have been provided during registration on the MSTC Portal. In case bank account details need to be changed, the Bidder should first make a request to get the bank account details updated on the MSTC Portal and then make a refund request. The request for change of bank account details should be sent by the Authorized Signatory of the Bidder from the registered mail address and should be sent to coalblock@mstcindia.co.in with the subject line "**Request to update bank details**". The request for updating bank account details should be accompanied by a scanned copy of cancelled cheque and bank mandate form duly filled and certified by the bank where the account has been opened.
